## AN ACT

1 ~~Making appropriations~~ PROVIDING FOR FUNDING to the Department of <—  
2 Education for alternative education programs and safe school  
3 programs.

4 The General Assembly of the Commonwealth of Pennsylvania  
5 hereby enacts as follows:

7 ~~(a) Alternative education program. The sum of \$10,400,000,~~  
8 ~~or as much thereof as may be necessary, is hereby appropriated~~

10 SECTION 1. ALTERNATIVE EDUCATION PROGRAM. <—

11 THE FUNDS APPROPRIATED TO THE DEPARTMENT OF EDUCATION  
12 PURSUANT TO SECTION 212 OF THE ACT OF MAY 5, 1999 (P.L. ,  
13 NO.1A), KNOWN AS THE GENERAL APPROPRIATION ACT OF 1999, for the  
14 fiscal year July 1, 1999, to June 30, 2000, FOR ALTERNATIVE <—  
15 SCHOOLS SHALL BE for the purpose of making grants to school  
16 districts to increase the access of school districts and

1 students to alternative education programs.

2 ~~(b) Safe school programs. The sum of \$4,000,000, or as much~~ <—  
3 ~~thereof as may be necessary, is hereby~~

4 SECTION 2. SAFE SCHOOL PROGRAMS. <—

5 AT LEAST \$2,000,000 OF THE FUNDS appropriated to the  
6 Department of Education, PURSUANT TO SECTION 212 OF THE ACT OF <—  
7 MAY 5, 1999 (P.L. , NO.1A), KNOWN AS THE GENERAL APPROPRIATION  
8 ACT OF 1999, for the fiscal year July 1, 1999, to June 30, 2000,  
9 ~~for payments~~ SHALL BE FOR GRANTS to school districts for the <—  
10 implementation of safe school programs within the school  
11 districts.
