AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial
- 4 schools; amending, revising, consolidating and changing the
- laws relating thereto, "further providing for continuing professional development; and directing school districts to
- 6 professional development; and directing school districts to 7 establish policies regarding student possession and self-
- 8 administration of certain asthma medications.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:
- 11 Section 1. Section 1205.1 of the act of March 10, 1949
- 12 (P.L.30, No.14), known as the Public School Code of 1949, is
- 13 amended by adding a subsection to read:
- 14 Section 1205.1. Continuing Professional Development. --* * *
- 15 (f) The requirements of this section and section 1205.2 do
- 16 not apply to a properly qualified private tutor in a program

- 2 Section 2. Section 1401 of the act is amended by adding a
- 3 definition to read:
- 4 Section 1401. Definitions.--As used in this article--
- 5 * * *
- 6 (12) "Asthma inhaler" means a physician-prescribed device
- 7 <u>used for self-administration of physician-prescribed medication</u>
- 8 to treat asthma.
- 9 Section 3. The act is amended by adding a section to read:
- 10 Section 1414.1. Possession and Use of Asthma Inhalers. <--
- 11 Every school district and area vocational technical school
- 12 <u>INHALERS.--(A) EACH SCHOOL ENTITY shall develop a written</u>
- 13 policy to allow for the possession and self-administration by a
- 14 school student of an asthma inhaler and the prescribed
- 15 medication to be administered thereby in a school setting. Such
- 16 policy may include, but not be limited to, the following:
- 17 (1) The requirement of a written statement from the
- 18 physician that provides the name of the drug, the dose, the
- 19 times when the medication is to be taken, and the diagnosis or
- 20 reason the medicine is needed, unless the reason should remain
- 21 confidential. The physician shall indicate the potential of any
- 22 serious reaction that may occur to the medication, as well as
- 23 any necessary emergency response. The physician shall state
- 24 whether the child is qualified and able to self-administer the
- 25 medication.
- 26 (2) The requirement of a written request from the parent or
- 27 quardian that the school district ENTITY comply with the
- 28 physician's order. The parent's note shall include a statement
- 29 <u>relieving the school ENTITY or any school employe of any</u>
- 30 responsibility for the benefits or consequences of the

- 1 medication when it is parent-authorized and physician-prescribed
- 2 and acknowledging that the school ENTITY bears no responsibility <-
- 3 for ensuring that the medication is taken.
- 4 (3) The ability of the school ENTITY to reserve the right to <-
- 5 require a physician statement for the continued use of any
- 6 medication beyond a specified time period. The school ENTITY <-
- 7 shall also restrict the availability of the asthma inhaler and
- 8 the prescribed medication contained therein from other students,
- 9 <u>with immediate confiscation of both the asthma inhaler and the</u>
- 10 medication and loss of privileges if the school policies are
- 11 <u>abused or ignored.</u>
- 12 (4) A requirement that a student demonstrate the capability
- 13 <u>for self-administration and for responsible behavior. The school</u>
- 14 ENTITY shall develop a system whereby the student will verify to <---
- 15 the certified school nurse that the student is capable of self-
- 16 <u>administration and has permission for carrying and taking the</u>
- 17 medication through the use of the asthma inhaler.
- 18 (B) AS USED IN THIS SECTION, "SCHOOL ENTITY" MEANS A SCHOOL
- 19 DISTRICT, INTERMEDIATE UNIT OR AREA VOCATIONAL-TECHNICAL SCHOOL.
- 20 Section 4. This act shall take effect in 60 days.
