AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- 5 laws relating thereto, " further providing for background
- 6 checks of prospective employees.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 111(c) and (e) of the act of March 10,
- 10 1949 (P.L.30, No.14), known as the Public School Code of 1949,
- 11 amended December 19, 1990 (P.L.1362, No.211) and June 25, 1997
- 12 (P.L.297, No.30), are amended to read:
- 13 Section 111. Background Checks of Prospective Employes;
- 14 Conviction of Employes of Certain Offenses. --* * *
- 15 (c) [Where the applicant is not a resident of the
- 16 Commonwealth, administrators] Administrators shall require the
- 17 applicant to submit with the application for employment a report
- 18 of Federal criminal history record information pursuant to the
- 19 Federal Bureau of Investigation appropriation of Title II of

- 1 Public Law 92-544, 86 Stat. 1115, and [the] such criminal
- 2 <u>history record information shall be no more than one (1) year</u>
- 3 old. The department shall be the intermediary for the purposes
- 4 of this section. For the purposes of this section, the applicant
- 5 shall submit a full set of fingerprints to the Pennsylvania
- 6 State Police, which shall forward it to the Federal Bureau of
- 7 <u>Investigation for a national criminal history record check.</u>
- 8 * * *
- 9 (e) No person subject to this act shall be employed in a
- 10 public or private school, intermediate unit or area vocational-
- 11 technical school where the report of criminal history record
- 12 information indicates the applicant has been convicted[, within
- 13 five (5) years immediately preceding the date of the report,] of
- 14 any of the following offenses:
- 15 (1) An offense under one or more of the following provisions
- 16 of Title 18 of the Pennsylvania Consolidated Statutes:
- 17 Chapter 25 (relating to criminal homicide).
- 18 Section 2702 (relating to aggravated assault).
- 19 Section 2709 (relating to harassment and stalking).
- 20 Section 2901 (relating to kidnapping).
- 21 Section 2902 (relating to unlawful restraint).
- 22 Section 3121 (relating to rape).
- 23 Section 3122.1 (relating to statutory sexual assault).
- 24 Section 3123 (relating to involuntary deviate sexual
- intercourse).
- 26 Section 3124.1 (relating to sexual assault).
- 27 Section 3125 (relating to aggravated indecent assault).
- 28 Section 3126 (relating to indecent assault).
- 29 Section 3127 (relating to indecent exposure).
- 30 Section 4302 (relating to incest).

- 1 Section 4303 (relating to concealing death of child).
- 2 Section 4304 (relating to endangering welfare of
- 3 children).
- 4 Section 4305 (relating to dealing in infant children).
- 5 A felony offense under section 5902(b) (relating to
- 6 prostitution and related offenses).
- 7 Section 5903(c) or (d) (relating to obscene and other
- 8 sexual materials and performances).
- 9 Section 6301 (relating to corruption of minors).
- 10 Section 6312 (relating to sexual abuse of children).
- 11 (2) An offense designated as a felony under the act of April
- 12 14, 1972 (P.L.233, No.64), known as "The Controlled Substance,
- 13 Drug, Device and Cosmetic Act."
- 14 (3) An out-of-State or Federal offense similar in nature to
- 15 those crimes listed in clauses (1) and (2).

- 17 Section 2. This act shall take effect in 60 days.
