SECTION 402.6 OF THE ACT, ADDED OCTOBER 30, 1996 24 25 (P.L.738, NO.133), IS AMENDED TO READ: 26 Section 402.6. Ineligibility of Incarcerated Employe .--27 [Nothing in this act] An employe shall [require] not be eligible 28 for payment of unemployment compensation benefits for any weeks 29 of unemployment during which the employe is incarcerated after a 30 conviction.
