- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania 2 Consolidated Statutes, further providing for willful failure
- 3 to pay support orders, FOR INVESTIGATING PERFORMANCE OF
- 4 COUNTY AGENCY, FOR ANNUAL REPORTS TO GOVERNOR AND GENERAL
- 5 ASSEMBLY AND FOR REPORTS TO DEPARTMENT AND CORONER.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 4354(a) of Title 23 of the Pennsylvania
- 9 Consolidated Statutes is amended to read:
- 10 § 4354. Willful failure to pay support order.
- 11 (a) Offense defined. -- An individual who willfully fails to
- 12 comply with a support order of a court of this Commonwealth when
- 13 the individual has the financial ability to comply with the
- 14 support order commits a [summary offense] misdemeanor of the
- 15 third degree.

- 17 SECTION 2. SECTIONS 6343, 6347 AND 6367 OF TITLE 23 ARE
- 18 AMENDED BY ADDING SUBSECTIONS TO READ:

- 1 § 6343. INVESTIGATING PERFORMANCE OF COUNTY AGENCY.

- 3 (C) DEPARTMENT REVIEWS AND REPORTS.--
- 4 (1) THE DEPARTMENT SHALL CONDUCT CHILD DEATH REVIEWS AND
- 5 PROVIDE WRITTEN REPORTS ON ANY CHILD DEATH WHERE CHILD ABUSE
- 6 IS SUSPECTED AND WHERE A COUNTY AGENCY HAS INVESTIGATED CHILD
- 7 ABUSE OR NEGLECT REPORTS RELATED TO THE CHILD OR TO OTHER
- 8 CHILDREN OF EITHER OF THE CHILD'S PARENTS OR HAS PROVIDED
- 9 PROTECTIVE OR GENERAL PROTECTIVE SERVICES INVOLVING THE CHILD
- 10 OR OTHER CHILDREN OF EITHER OF THE CHILD'S PARENTS. AGENCY
- 11 PERFORMANCE, INCLUDING, BUT NOT LIMITED TO, THE INVESTIGATION
- 12 OF PRIOR CHILD ABUSE OR NEGLECT REPORTS, ASSESSMENT OF RISK,
- 13 <u>ACCEPTANCE OF THE FAMILY FOR SERVICES, PROVISION OF SERVICES,</u>
- 14 CASE CLOSURE AND COMPLIANCE WITH THIS CHAPTER AND RELATED
- 15 REGULATIONS, MUST BE ANALYZED IN EACH REVIEW AND REPORT. AN
- 16 EXPLANATION REGARDING THE NATURE AND EXTENT OF THE REVIEW
- 17 SHALL BE PROVIDED IN EACH REPORT.
- 18 (2) ON AND AFTER JANUARY 1, 2003, THE CHILD DEATH REVIEW
- 19 AND REPORT SHALL BE COMPLETED NO LATER THAN SIX MONTHS
- 20 FOLLOWING THE DATE OF THE ORAL REPORT OF SUSPECTED CHILD
- 21 ABUSE TO THE DEPARTMENT. A COPY OF EACH CHILD DEATH REPORT
- 22 SHALL BE MAINTAINED IN THE APPROPRIATE HARRISBURG OFFICE OF
- THE DEPARTMENT.
- 24 (3) THIS SECTION SHALL NOT BE CONSTRUED TO PRECLUDE THE
- 25 <u>DEPARTMENT FROM REVIEWING AND PROVIDING A WRITTEN REPORT ON</u>
- 26 ANY CHILD DEATH WHERE CHILD ABUSE IS SUSPECTED OR CONFIRMED
- 27 AND THE AGENCY HAD NO PRIOR INVOLVEMENT WITH THE CHILD OR THE

- 1 (C) REPORTS ON CHILD DEATHS.--THE DEPARTMENT SHALL PREPARE
- 2 AND TRANSMIT ANNUALLY TO THE GOVERNOR AND TO THE GENERAL
- 3 ASSEMBLY A REPORT ON ITS FINDINGS AND RECOMMENDATIONS REGARDING
- 4 ITS CHILD DEATH REVIEWS AND REPORTS CONDUCTED UNDER SECTION
- 5 6343(C) (RELATING TO INVESTIGATING PERFORMANCE OF COUNTY
- 6 AGENCY). THE ANNUAL REPORT SHALL INCLUDE, BUT NOT BE LIMITED TO,
- 7 THE FOLLOWING:
- 8 (1) A BREAKDOWN OF CHILD DEATHS REVIEWED VERSUS THOSE
- 9 NOT REVIEWED AND A DISCUSSION EXPLAINING THE LACK OF REVIEWS
- 10 FOR SOME CHILD DEATHS.
- 11 (2) THE REGULATORY COMPLIANCE PROBLEMS IDENTIFIED IN THE
- 12 COURSE OF THE CHILD DEATH REVIEWS AND A DISCUSSION OUTLINING
- 13 THE ACTIONS TAKEN BY THE DEPARTMENT AND THE COUNTY AGENCIES.
- 14 (3) THE PRACTICE OR DECISION-MAKING PROBLEMS IDENTIFIED
- 15 IN THE COURSE OF THE CHILD DEATH REVIEWS AND A DISCUSSION
- 16 OUTLINING THE ACTIONS TAKEN BY THE DEPARTMENT AND THE COUNTY
- 17 AGENCIES.
- 18 (4) THE GOOD PRACTICE, EFFECTIVE DECISION MAKING AND
- 19 REGULATORY COMPLIANCE IDENTIFIED IN THE COURSE OF THE CHILD
- 20 DEATH REVIEWS.
- 21 (5) THE NUMBERS OF LICENSE REVOCATIONS, PROVISIONAL
- 22 LICENSES AND FULL LICENSES GIVEN TO COUNTY AGENCIES REVIEWED
- 23 UNDER SECTION 6343(C).
- 24 (6) RECOMMENDATIONS FOR ADMINISTRATIVE, REGULATORY OR
- 25 <u>STATUTORY CHANGE, INCLUDING IMPROVEMENT OF THE DEPARTMENT'S</u>

- 30 (C) REPORTS OF CHILD DEATH. -- IN ADDITION TO THE CHILD ABUSE

- 1 REPORT REQUIRED UNDER SUBSECTION (A), A COUNTY AGENCY SHALL
- 2 <u>IMMEDIATELY PROVIDE INFORMATION TO THE DEPARTMENT REGARDING ITS</u>
- 3 INVOLVEMENT WITH THE CHILD AND WITH EITHER OF THE CHILD'S
- 4 PARENTS WHEN A CHILD DIES AND CHILD ABUSE IS SUSPECTED. THE
- 5 COUNTY AGENCY SHALL INFORM THE DEPARTMENT OF ANY HISTORY OF
- 6 PROTECTIVE OR GENERAL PROTECTIVE SERVICES PROVIDED TO THE CHILD
- 7 OR TO OTHER CHILDREN OF EITHER OF THE CHILD'S PARENTS BY THE
- 8 COUNTY AGENCY UNDER THIS CHAPTER OR BY COURT ORDER AND SHALL
- 9 <u>INFORM THE DEPARTMENT IF THE CHILD WAS IN THE AGENCY'S CUSTODY</u>
- 10 AT THE TIME OF THE CHILD'S DEATH. THE COUNTY AGENCY SHALL
- 11 PROVIDE THIS INFORMATION IN WRITING ON FORMS PROVIDED BY THE
- 12 <u>DEPARTMENT WITHIN 48 HOURS OF THE ORAL REPORT.</u>
- 13 SECTION 3. THE DEPARTMENT OF PUBLIC WELFARE SHALL PROMULGATE
- 14 REGULATIONS NECESSARY FOR IMPLEMENTING THE AMENDMENT OF 23
- 15 PA.C.S. §§ 6343, 6347 AND 6367.
- 16 Section 2 4. The amendment of 23 Pa.C.S. § 4354(a) shall

- 19 Section 3 5. This act shall take effect in 60 days.
