26	Section 1. Section 24 of the act of May 28, 1937 (P.L.955,
27	No.265), known as the Housing Authorities Law, amended October

28 19, 1967 (P.L.461, No.218), is amended to read:

Section 24. Reports.--In addition to any other material
which an Authority must file with the Department of Community
[Affairs] and Economic Development according to the provisions
of this act, it shall file with said department--

5 (a) A copy of any rules, regulations or resolutions, and 6 amendments thereto, adopted by it from time to time.

7 (b) At least once each year, a report of its activities for 8 the preceding year, and such other reports as said department 9 may require.

An Authority must file with the governing body of the city or 10 11 county within the territorial limits of which the Authority 12 functions an annual report containing a statement of activities 13 and a complete operating and financial statement covering the operations of the Authority during the previous year. Within 14 sixty (60) days following the submission of the report by an 15 16 Authority the governing body shall hold a public hearing on the 17 substance of the report and any matters pertaining to the 18 operation of the Authority. 19 Section 2. This act shall take effect in 60 days.
