AN ACT

1 Redesignating the Apollo Bridge carrying State Route 66 between
2 Oklahoma Borough, Westmoreland County, and Apollo Borough,
3 Armstrong County, as the Leonard C. Miller Bridge; <—
4 DESIGNATING A PORTION OF US ROUTE 119 IN INDIANA COUNTY AS
5 THE PATRICK J. STAPLETON MEMORIAL HIGHWAY; AND DESIGNATING A
6 PORTION OF STATE ROUTE 1026 IN UNITY TOWNSHIP, WESTMORELAND
7 COUNTY, AS DEPASQUALE WAY.

8 The General Assembly of the Commonwealth of Pennsylvania
9 hereby enacts as follows:

10 Section 1. Leonard C. Miller Bridge.

11 (a) Redesignation.--The Apollo Bridge carrying State Route
12 66 across the Kiskiminetas River between Oklahoma Borough,
13 Westmoreland County, and Apollo Borough, Armstrong County, is
14 hereby redesignated and shall be known as the Leonard C. Miller
15 Bridge.

1 (b) Signs.--The Department of Transportation shall erect and
2 maintain signs to indicate the redesignation under subsection
3 (a).

4 SECTION 2. PATRICK J. STAPLETON MEMORIAL HIGHWAY. <—

5 (A) DESIGNATION.--THE PORTION OF US ROUTE 119 IN INDIANA
6 COUNTY BETWEEN US ROUTE 422 AND US ROUTE 22 IS HEREBY DESIGNATED
7 AS THE PATRICK J. STAPLETON MEMORIAL HIGHWAY.

8 (B) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
9 MAINTAIN APPROPRIATE SIGNS TO INDICATE THE DESIGNATION IN
10 SUBSECTION (A).

11 SECTION 3. DEPASQUALE WAY.

12 (A) DESIGNATION.--THE PORTION OF STATE ROUTE 1026 LOCATED ON
13 THE UNDERPASS UNDER THE NORFOLK SOUTHERN RAILWAY AT THE NEAREST
14 INTERSECTION OF STATE ROUTE 981 IN UNITY TOWNSHIP IN
15 WESTMORELAND COUNTY IS HEREBY DESIGNATED AS DEPASQUALE WAY.

16 (B) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
17 MAINTAIN APPROPRIATE SIGNS TO INDICATE THE DESIGNATION IN
18 SUBSECTION (A).
