- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, further providing for
- detention of children under certain circumstances.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 6325 of Title 42 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 6325. Detention of child.
- 9 [A] (a) General rule.--Except as otherwise provided for in
- 10 <u>subsection (b)</u>, a child taken into custody shall not be detained
- 11 or placed in shelter care prior to the hearing on the petition
- 12 unless his detention or care is required to protect the person
- 13 or property of others or of the child or because the child may
- 14 abscond or be removed from the jurisdiction of the court or
- 15 because he has no parent, guardian, or custodian or other person
- 16 able to provide supervision and care for him and return him to
- 17 the court when required, or an order for his detention or
- 18 shelter care has been made by the court pursuant to this

- 1 chapter.
- 2 (b) Possession of a firearm on school property.--
- 3 (1) A child taken into custody for a violation of 18
- 4 Pa.C.S. § 912(b) (relating to possession of weapon on school
- 5 property) when the weapon is a firearm or explosive device
- 6 shall be detained in the appropriate juvenile justice setting
- 7 until the court or master conducts an informal hearing
- 8 pursuant to section 6332 (relating to informal hearing) to
- 9 <u>determine whether the child's further detention is required</u>
- to protect the person or property of others.
- 11 (2) Prior to the informal hearing, but in no case not
- 12 <u>later than 72 hours after the child has been placed in</u>
- detention or shelter care, the court or master shall order
- the child to undergo a psychological evaluation by a licensed
- physician or clinical psychologist to determine whether the
- child is a clear and present danger to himself or others. A
- 17 report of the evaluation shall be made available to the court
- 18 prior to the informal hearing.
- 19 Section 2. This act shall take effect in 30 days.
