- 10 (a) Short title.--This act CHAPTER shall be known and may be <--
- 11 cited as the Capital Budget Act of 2002-2003.
- 12 (b) Supplements.--A reference to this act CHAPTER shall be <--
- 13 deemed to include a reference to the supplements to this act
- 14 CHAPTER. <—
- 15 (c) Capital Facilities Debt Enabling Act.--The provisions
- 16 and definitions of Chapter 3 of the act of February 9, 1999
- 17 (P.L.1, No.1), known as The Capital Facilities Debt Enabling
- 18 Act, shall apply to this act CHAPTER to the extent they are not <-
- 19 inconsistent with this act CHAPTER.
- 20 Section 2 102. Overall limitations on debt to be incurred for
- 21 capital projects.
- 22 The maximum principal amount of additional debt to be
- 23 incurred during the 2002-2003 fiscal year, for capital projects
- 24 specifically itemized in a capital budget pursuant to section
- 25 7(a)(4) of Article VIII of the Constitution of Pennsylvania, and
- 26 the fund to be charged with the repayment of such debt, shall,
- 27 with respect to each category of capital projects, be as

- CHAPTER 3 <—
- 15 CAPITAL PROJECTS OVERSIGHT
- 16 SECTION 301. SHORT TITLE OF CHAPTER.
- 17 THIS CHAPTER SHALL BE KNOWN AND MAY BE CITED AS THE CAPITAL
- 18 PROJECTS OVERSIGHT ACT.
- 19 SECTION 302. DEFINITIONS.
- 20 THE FOLLOWING WORDS AND PHRASES WHEN USED IN THIS CHAPTER
- 21 SHALL HAVE THE MEANINGS GIVEN TO THEM IN THIS SECTION UNLESS THE
- 22 CONTEXT CLEARLY INDICATES OTHERWISE:
- 23 "BOARD." THE CAPITAL PROJECTS OVERSIGHT BOARD ESTABLISHED IN
- 24 SECTION 303.
- 25 SECTION 303. ESTABLISHMENT.
- 26 THE CAPITAL PROJECTS OVERSIGHT BOARD IS ESTABLISHED IN ORDER
- 27 TO PROVIDE REVIEW AND OVERSIGHT OF CAPITAL PROJECTS. THE BOARD
- 28 SHALL ALSO ASSIST IN PROVIDING INFORMATION RELATING TO WAYS EACH
- 29 SPECIFIC PROJECT BENEFITS THE COMMUNITY AT LARGE.
- 30 SECTION 304. MEMBERSHIP.

- 1 THE BOARD SHALL CONSIST OF NINE MEMBERS. THE BOARD SHALL
- 2 REFLECT THE RACIAL AND ETHNIC DIVERSITY OF THIS COMMONWEALTH.
- 3 THE GOVERNOR SHALL DESIGNATE ONE OF THE APPOINTED MEMBERS AS
- 4 CHAIRPERSON OF THE BOARD. THE FOLLOWING SHALL SERVE ON THE
- 5 BOARD:
- 6 (1) ONE MEMBER APPOINTED BY THE PRESIDENT PRO TEMPORE OF
- 7 THE SENATE.
- 8 (2) ONE MEMBER APPOINTED BY THE MINORITY LEADER OF THE
- 9 SENATE.
- 10 (3) ONE MEMBER APPOINTED BY THE SPEAKER OF THE HOUSE OF
- 11 REPRESENTATIVES.
- 12 (4) ONE MEMBER APPOINTED BY THE MINORITY LEADER OF THE
- 13 HOUSE OF REPRESENTATIVES.
- 14 (5) FIVE MEMBERS FROM ACROSS THIS COMMONWEALTH APPOINTED
- 15 BY THE GOVERNOR.
- 16 SECTION 305. TERM OF OFFICE.
- 17 THE TERMS OF OFFICE FOR APPOINTED BOARD MEMBERS SHALL BE TWO
- 18 YEARS AND UNTIL THEIR SUCCESSORS HAVE BEEN APPOINTED, BUT NO
- 19 MEMBER SHALL SERVE MORE THAN SIX MONTHS BEYOND THE EXPIRATION OF
- 20 THE MEMBER'S TERM UNLESS REAPPOINTED. IN NO EVENT SHALL A MEMBER
- 21 SERVE MORE THAN TWO TERMS. TERMS OF OFFICE OF MEMBERS SHALL
- 22 EXPIRE ON THE THIRD TUESDAY OF JANUARY OF EACH ODD-NUMBERED
- 23 YEAR. IN THE CASE OF A VACANCY IN A POSITION FILLED BY
- 24 APPOINTMENT OF THE GOVERNOR, THE GOVERNOR SHALL MAKE AN
- 25 APPOINTMENT FOR THE UNEXPIRED PORTION OF THE TERM. IN THE CASE
- 26 OF A VACANCY IN A POSITION FILLED BY APPOINTMENT OF A
- 27 LEGISLATIVE LEADER, THAT LEGISLATIVE LEADER SHALL MAKE AN
- 28 APPOINTMENT FOR THE UNEXPIRED PORTION OF THE TERM.
- 29 SECTION 306. QUORUM AND MEETINGS.
- 30 THE BOARD SHALL MEET LEAST TWICE PER YEAR, AS WELL AS AT THE

- CALL OF THE GOVERNOR. A MAJORITY OF THE MEMBERS OF THE BOARD
- 2 SHALL CONSTITUTE A QUORUM.
- 3 SECTION 307. COMPENSATION AND EXPENSES.
- 4 (A) COMPENSATION. -- THE MEMBERS OF THE BOARD SHALL SERVE
- 5 WITHOUT COMPENSATION. HOWEVER, MEMBERS OTHER THAN THE GOVERNOR
- SHALL BE ENTITLED TO RECEIVE TRAVELING AND OTHER REASONABLE 6
- 7 EXPENSES INCURRED IN THE DISCHARGE OF THEIR OFFICIAL DUTIES.
- 8 (B) EXPENSES. -- THE EXPENSES OF THE BOARD PROVIDED FOR IN
- THIS SECTION SHALL BE BORNE BY THE EXECUTIVE OFFICE OF THE
- 10 GOVERNOR.
- 11 SECTION 308. PUBLICATION OF PROJECTS ON INTERNET.
- 12 THE BOARD, WITHIN 120 DAYS OF THE FINAL APPOINTMENT TO THE
- 13 INITIAL BOARD, SHALL ELECTRONICALLY PUBLISH ON THE INTERNET, A
- 14 LIST OF THE PROJECTS FOR WHICH THE BOARD HAS OVERSIGHT AS WELL
- 15 AS THE TIMES AND DATES OF ALL BOARD MEETINGS.
- 16 SECTION 309. ANNUAL REPORT.
- 17 THE BOARD SHALL, NO LATER THAN JULY 1 OF EACH YEAR, PREPARE A
- 18 COMPREHENSIVE ANNUAL REPORT DETAILING ITS REVIEW OF EACH CAPITAL
- 19 PROJECT.
- 20 SECTION 310. APPLICABILITY.
- THIS CHAPTER SHALL ONLY APPLY TO CAPITAL PROJECTS: 21
- 22 (1) INVOLVING EXPENDITURES OVER \$5,000,000.
- 23 (2) UNDER CHAPTER 1.
- 24 CHAPTER 7
- 25 MISCELLANEOUS PROVISIONS
- 26 Section 3 701. Effective date.
- 27 This act shall take effect July 1, 2002, or immediately,
- 28 whichever is later.
