AN ACT

- 1 Providing for pharmaceutical discount card minimum standards.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the
- 6 Pharmaceutical Discount Card Minimum Standards Act.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- 11 "Average wholesale price." The cost of a dispensed drug
- 12 based upon the price published in a national drug pricing system
- 13 in current use by the Department of Aging as the average
- 14 wholesale cost of a prescription drug in the most common package
- 15 size.

- 1 "Prescription drug." Any human drug required by Federal law,
- 2 the act of April 14, 1972 (P.L.233, No.64), known as The
- 3 Controlled Substance, Drug, Device and Cosmetic Act, or
- 4 regulations promulgated under either, to be dispensed only by a
- 5 prescription, including finished dosage forms and active
- 6 ingredients subject to section 503(b) of the Federal Food, Drug,
- 7 and Cosmetic Act (52 Stat. 1040, 21 U.S.C. § 503(b)).
- 8 "Wholesale distributor of prescription drugs." A person who
- 9 engages in the wholesale distribution of prescription drugs,
- 10 including, but not limited to, manufacturers, repackers, own-
- 11 label distributors, private-label distributors or jobbers,
- 12 warehouses, including manufacturers' and distributors'
- 13 warehouses, chain drug warehouses and wholesale drug warehouses,
- 14 independent wholesale drug traders and retail pharmacies that
- 15 conduct wholesale distributions.
- 16 Section 3. Discount card minimum standards.
- 17 Any wholesale distributor of prescription drugs that offers a
- 18 pharmaceutical discount card program to a resident in this
- 19 Commonwealth shall be required to meet the following minimum
- 20 standards:
- 21 (1) The dispensing fee paid to the pharmacies shall be
- 22 no less than \$4 for each prescription filled as part of the
- 23 discount card program.
- 24 (2) A pharmacy that fills a prescription under a
- discount card program shall be reimbursed within 30 days
- 26 after the sale to a customer using the wholesaler's discount
- 27 card. A wholesaler who fails to reimburse the pharmacies
- within this 30-day period shall be liable for a civil penalty
- in the amount of 6% of the reimbursement required to be paid.
- 30 (3) A wholesaler must provide the same discount price to

- 1 all consumers enrolled under the discount card program.
- 2 (4) At a minimum, the wholesaler must offer the
- 3 prescription drug to the pharmacies at 12% below the average
- 4 wholesale price.
- 5 Section 4. Disclosure of information.
- 6 Each wholesale distributor of prescription drugs that offers
- 7 a pharmaceutical discount card program shall be required to
- 8 disclose the following information for each prescription drug
- 9 covered by the discount card program to the State Board of
- 10 Pharmacy no later than 30 days after the last day of each
- 11 quarter:
- 12 (1) The name and address of the manufacturer or company
- name that sold each prescription drug to the wholesaler.
- 14 (2) The average wholesale price of all prescription
- drugs covered by the wholesaler's discount card.
- 16 (3) The regular purchase price paid by the wholesaler
- for each prescription drug.
- 18 (4) The number of people that participated in the
- 19 wholesaler's discount card program.
- 20 Section 5. Annual report.
- 21 Each wholesale distributor of prescription drugs that offers
- 22 a pharmaceutical discount card program must submit an annual
- 23 report to the State Board of Pharmacy, who must in turn submit
- 24 the report to the General Assembly no later than December 15 of
- 25 each year, that includes, but is not limited to, the following
- 26 information:
- 27 (1) A description of how many consumers participated in
- the discount card program for the year.
- 29 (2) The number of prescriptions paid for in part or full
- in the discount card program.

- 1 (3) The consumer price paid for each of the prescription 2 drugs covered by the discount card program.
- 3 (4) The wholesale and market price paid for each of the 4 prescription drugs covered by the discount card program.
- 5 (5) The average wholesale price paid for each of the 6 prescription drugs covered by the discount card program.
- 7 (6) Geographic information by county and region 8 regarding utilization of the prescription drugs covered by 9 the discount card program.
- 10 Section 6. Effective date.
- 11 This act shall take effect January 1, 2003.
