- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:

1 Section 1. Designation.

2 The Keystone Building is designated as, and shall be referred

3 to as, the K. Leroy Irvis Office Building.

4 SECTION 1. SOUTH OFFICE BUILDING.

5 (A) DESIGNATION.--THE SOUTH OFFICE BUILDING IN THE CITY OF 6 HARRISBURG IS DESIGNATED AS, AND SHALL BE REFERRED TO AS, THE 7 SPEAKER K. LEROY IRVIS OFFICE BUILDING.

8 (B) USE.--THE USE OF THE SPEAKER K. LEROY IRVIS OFFICE 9 BUILDING IN THE CITY OF HARRISBURG IS HEREBY GRANTED TO THE 10 GENERAL ASSEMBLY. THE BI-PARTISAN MANAGEMENT COMMITTEE OF THE 11 HOUSE OF REPRESENTATIVES SHALL ALLOCATE AND REALLOCATE THE SPACE FOR SUCH LEGISLATIVE AND JUDICIAL PURPOSES AS IT DEEMS 12 13 NECESSARY. THE SPACE CURRENTLY UTILIZED BY THE COMMONWEALTH 14 COURT SHALL BECOME AVAILABLE FOR ALLOCATION BY THE COMMITTEE 15 UPON THE COURT'S RELOCATION TO AND OCCUPATION OF SPACE IN THE 16 PENNSYLVANIA JUDICIAL CENTER.

17 SECTION 2. NORTH OFFICE BUILDING.

18 THE USE OF THE NORTH OFFICE BUILDING IN THE CITY OF 19 HARRISBURG IS HEREBY GRANTED TO THE GENERAL ASSEMBLY. THE 20 PRESIDENT PRO TEMPORE OF THE SENATE SHALL, AFTER CONSULTATION 21 WITH THE COMMITTEE ON MANAGEMENT OPERATIONS OF THE SENATE, 22 ALLOCATE AND REALLOCATE SPACE FOR SUCH LEGISLATIVE PURPOSES AS 23 HE DEEMS APPROPRIATE. THE DEPARTMENT OF GENERAL SERVICES AND THE DEPARTMENT OF STATE MAY CONTINUE TO USE SUCH SPACE IN THE NORTH 24 25 OFFICE BUILDING AS THE DEPARTMENTS ARE USING AS OF THE EFFECTIVE 26 DATE OF THIS SECTION. IF THE DEPARTMENT OF GENERAL SERVICES OR 27 THE DEPARTMENT OF STATE VACATES ITS SPACE IN THE NORTH OFFICE 28 BUILDING, THE USE OF THE SPACE SHALL BE TRANSFERRED TO THE 29 GENERAL ASSEMBLY FOR USE IN ACCORDANCE WITH THIS SECTION. 30 HEARING ROOMS IN THE NORTH OFFICE BUILDING FORMERLY UTILIZED BY - 2 -20020H2863B4720

THE PENNSYLVANIA PUBLIC UTILITY COMMISSION SHALL BE AVAILABLE
FOR USE BY THE COMMITTEES OF BOTH THE SENATE AND THE HOUSE OF
REPRESENTATIVES AND THE EXECUTIVE BRANCH DEPARTMENTS LOCATED IN
THE BUILDING.
