A RESOLUTION

- 1 Directing the Legislative Budget and Finance Committee to
- 2 conduct a study on the underlying causes and impact of rising
- 3 natural gas prices.
- 4 WHEREAS, The spot price for natural gas has risen from
- 5 approximately \$2 per thousand cubic feet in 1998 to over \$10 per
- 6 thousand cubic feet in early 2001; and
- WHEREAS, According to the United States Department of Energy,
- 8 these prices exceed any historical or dollar-adjusted price in
- 9 the last 20 years; and
- 10 WHEREAS, According to the United States Department of Energy,
- 11 over 50% of households in the United States are heated with
- 12 natural gas; and
- 13 WHEREAS, According to the United States Census Bureau,
- 14 natural gas is the primary residential heating fuel in several

- 1 major areas of population in this Commonwealth, including
- 2 Philadelphia, Pittsburgh and Erie; and
- 3 WHEREAS, According to numerous reports by residential and
- 4 small business ratepayers across this Commonwealth, monthly
- 5 natural gas bills have gone up approximately 70% or more; and
- 6 WHEREAS, These natural gas price increases are placing a
- 7 severe burden on senior citizens, families and businesses across
- 8 this Commonwealth; and
- 9 WHEREAS, Neighboring states have provided hundreds of
- 10 millions of dollars of additional state and private resources to
- 11 help their citizens in recent months; and
- 12 WHEREAS, The State government of the Commonwealth must
- 13 respond to the growing energy crisis; therefore be it
- 14 RESOLVED, That the House of Representatives direct the
- 15 Legislative Budget and Finance Committee to conduct a study on
- 16 the underlying causes and impact of rising natural gas prices;
- 17 and be it further
- 18 RESOLVED, That its report include a review of natural gas
- 19 production and capacity in this Commonwealth and sources of
- 20 natural gas to natural gas distribution companies in this
- 21 Commonwealth; and be it further
- 22 RESOLVED, That its report include recommendations about what
- 23 additional State assistance could be provided to senior citizens
- 24 and other vulnerable populations; and be it further
- 25 RESOLVED, That the Legislative Budget and Finance Committee
- 26 report its findings and recommendations to the House of
- 27 Representatives no later than 90 days after the adoption of this
- 28 resolution.
