AN ACT

- 1 Providing for bonus pay for certain persons involved in the War 2 on Terrorism; and making an appropriation.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the War on
- 7 Terrorism Compensation Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Soldier." Any United States military reservist whose
- 13 reserve unit is in Pennsylvania and any member of the
- 14 Pennsylvania National Guard who was called to active duty on or
- 15 after September 11, 2001, to participate in the War on Terrorism
- 16 and who has completed one month of active duty. Proof of such
- 17 service shall be the official military records of the United

- 1 States or such other evidence as is deemed sufficient by the
- 2 Adjutant General.
- 3 "War on Terrorism." Military efforts in the United States
- 4 and abroad directly resulting from the terrorism attacks on the
- 5 Pentagon and the World Trade Center on September 11, 2001. For
- 6 the purposes of this act, the War on Terrorism shall be deemed
- 7 to have ended when military efforts cease as ordered by the
- 8 Commander-in-Chief of the United States Armed Forces.
- 9 Section 3. Bonus payment.
- 10 (a) Compensation. -- A bonus payment of \$250 shall be made to
- 11 each soldier who is determined to be eligible pursuant to
- 12 section 4(a).
- 13 (b) Exclusion from compensation. -- Any individual who has
- 14 received a bonus, gratuity or compensation of a nature similar
- 15 to that provided for by this act from any other state in the
- 16 United States is ineligible for compensation. This exclusion
- 17 does not apply to a similar bonus, gratuity or compensation from
- 18 the Federal Government.
- 19 Section 4. Application for compensation.
- 20 (a) Application to Adjutant General.--Applications shall be
- 21 made by a soldier, the facility entitled under section 5(a) or
- 22 the beneficiaries designated under section 5(b) on a form
- 23 provided by the Adjutant General. The Adjutant General shall
- 24 ascertain the applicants who are eligible to receive a bonus
- 25 payment pursuant to this act.
- 26 (b) Time for filing application. -- Applications may be filed
- 27 by a soldier after the soldier has completed one month of active
- 28 duty. The Adjutant General shall not accept or consider any
- 29 application filed five years after the cessation of the War on
- 30 Terrorism.

- 1 (c) Payment.--Every applicant shall designate in the
- 2 application the person or entity to whom payment under this act
- 3 shall be made.
- 4 Section 5. Persons to whom payments shall be made in case of
- 5 incompetence or death.
- 6 (a) Incompetence.--In a case where the soldier is
- 7 incompetent, if no guardian has been appointed, payment shall be
- 8 made for the benefit of the soldier to the person who is
- 9 entitled to payment under subsection (b) or, in the absence of
- 10 any such person and if the soldier is in a facility, to the
- 11 person in charge of the facility to be expended for the clothing
- 12 and incidental needs of the soldier. No part of the compensation
- 13 paid to any facility shall be used for the maintenance of the
- 14 soldier. A statement from the person in charge of the facility
- 15 in which the soldier resides shall be evidence to determine the
- 16 competence of the soldier.
- 17 (b) Death.--In the case of the death of a soldier, payment
- 18 shall be made, in the order named, to the:
- 19 (1) surviving spouse unless the spouse was living
- 20 separate and apart from the soldier at the time of departure
- 21 for active service;
- 22 (2) surviving children, share and share alike; or
- 23 (3) surviving parents.
- 24 (c) Definitions.--As used in this section, the following
- 25 words and phrases shall have the meanings given to them in this
- 26 subsection:
- 27 "Facility." Any mental health establishment, hospital,
- 28 clinic, institution, center, day-care center, base service unit,
- 29 community mental health center or other organizational unit, or
- 30 part thereof, which is devoted primarily to the diagnosis,

- 1 treatment, care, rehabilitation or detention of mentally
- 2 disabled persons.
- 3 "Parents." Includes persons who, for a period of not less
- 4 than one year, acted in the capacity of a foster parent to the
- 5 soldier immediately prior to the soldier having attained 18
- 6 years of age.
- 7 Section 6. Applicant to designate beneficiaries.
- 8 Every person making application for compensation shall set
- 9 forth in the application the names and addresses of all persons
- 10 who, under this act, would be entitled to receive compensation
- 11 in the event of the death of the applicant. If the applicant
- 12 dies before the payment of the compensation, the application
- 13 shall be deemed to inure to the benefit of the person next
- 14 entitled to compensation, and payment shall be made to the
- 15 person upon proof of identity satisfactory to the Adjutant
- 16 General. If no person designated in this act as being entitled
- 17 to compensation survives the soldier, the right to the
- 18 compensation shall cease.
- 19 Section 7. Exemption from attachment, etc.
- 20 No sum payable under this act to a soldier or to any other
- 21 person under this act shall be subject to attachment, levy or
- 22 seizure under any legal or equitable process and shall be exempt
- 23 from all State taxation. No right to compensation under this act
- 24 shall be assignable, except as otherwise provided in this act,
- 25 or shall serve as a security for any loan. Any assignment or
- 26 loan made in violation of this section shall be void.
- 27 Assignments to any incorporated or unincorporated organization
- 28 of soldiers or veterans, any nonprofit corporation formed solely
- 29 for the purpose of aiding disabled or incapacitated soldiers or
- 30 veterans and the State Veterans' Commission shall be valid.

- 1 Section 8. Penalty for charging fees for assisting soldiers.
- 2 A person who charges or collects or attempts to charge or
- 3 collect, either directly or indirectly, any fee or other
- 4 compensation for assisting, in any manner, a soldier in
- 5 obtaining any of the benefits provided under this act commits a
- 6 misdemeanor of the second degree.
- 7 Section 9. Administration of compensation program.
- 8 The Adjutant General shall administer the compensation
- 9 program. For that purpose application forms shall be prepared
- 10 and distributed, applications shall be investigated, and, if
- 11 satisfied of the proof of an application, compensation shall be
- 12 approved and payment of compensation shall be made. The Adjutant
- 13 General shall promulgate rules and regulations to implement,
- 14 administer and enforce this act. The Adjutant General shall, as
- 15 soon as practicable after the effective date of this act,
- 16 prepare and distribute a digest explaining the provisions of
- 17 this act to assist soldiers in filing their applications and
- 18 shall, from time to time, prepare and distribute additional or
- 19 supplementary information as may be found necessary. The
- 20 Adjutant General shall enlist, as far as possible, the services
- 21 of soldier and veteran organizations in this Commonwealth in the
- 22 dissemination of the information.
- 23 Section 10. Appropriation.
- The General Assembly shall appropriate the sum of \$2,000,000
- 25 to carry out the provisions of this act.
- 26 Section 11. Effective date.
- 27 This act shall take effect in 60 days.
