## AN ACT

- Amending Title 18 (Crimes and Offenses) of the Pennsylvania
  Consolidated Statutes, further providing for tattooing; and
  prohibiting certain body piercing; AND DEFINING THE OFFENSE
  OF GREYHOUND RACING.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 6311 of Title 18 of the Pennsylvania
- 8 Consolidated Statutes is amended to read:
- 9 § 6311. Tattooing and body piercing.
- 10 (a) Tattooing.--A person [is guilty of a misdemeanor of the
- 11 third degree] commits an offense if he tattoos any person under
- 12 the age of 18 years without the [consent of the] parent or
- 13 quardian of such person[.] giving consent for the tattooing of
- 14 the person and being present at the time of the tattooing of the
- 15 person.
- 16 (b) Body piercing. -- A person commits an offense if FOR

- 1 COMPENSATION he punctures a part of the body of any person under
- 2 the age of 18 years with the intent to create a permanent hole
- 3 for cosmetic purposes without the parent or guardian of such
- 4 person giving consent for the piercing of the person and being
- 5 present at the time of the piercing of the person.
- 6 (c) Grading. -- A person who commits an offense under this
- 7 <u>section shall be quilty of a misdemeanor of the third degree for</u>
- 8 the first offense. A person who commits a second or subsequent
- 9 offense under this section within one year of the preceding
- 10 offense commits a misdemeanor of the second degree.
- 11 SECTION 2. TITLE 18 IS AMENDED BY ADDING A SECTION TO READ: <---
- 12 § 7516. GREYHOUND RACING.
- A PERSON WHO HOLDS, CONDUCTS OR OPERATES A GREYHOUND RACE FOR
- 14 PUBLIC EXHIBITION IN THIS COMMONWEALTH FOR MONETARY REMUNERATION
- 15 COMMITS A MISDEMEANOR OF THE FIRST DEGREE.
- 16 Section  $\frac{2}{3}$ . This act shall take effect in 60 days.
