## AN ACT

- Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An 2 act relating to tax reform and State taxation by codifying 3 and enumerating certain subjects of taxation and imposing taxes thereon; providing procedures for the payment, 5 collection, administration and enforcement thereof; providing for tax credits in certain cases; conferring powers and 7 imposing duties upon the Department of Revenue, certain 8 employers, fiduciaries, individuals, persons, corporations and other entities; prescribing crimes, offenses and 9 10 penalties," further providing for exclusions from the sales 11 and use tax.
- 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- 14 Section 1. Section 204 of the act of March 4, 1971 (P.L.6,
- 15 No.2), known as the Tax Reform Code of 1971, is amended by
- 16 adding a clause to read:
- 17 Section 204. Exclusions from Tax. -- The tax imposed by
- 18 section 202 shall not be imposed upon any of the following:
- 19 \* \* \*

- 1 (64) The sale at retail or use of tangible personal property
- 2 <u>directly and predominantly used to facilitate reading and</u>
- 3 communicating, including computer and related equipment, by
- 4 persons who are blind or visually impaired. For the purpose of
- 5 this clause, the following terms or phrases shall have the
- 6 <u>following meanings:</u>
- 7 (i) "blind" means having a visual acuity of twenty/two
- 8 <u>hundred or less in the better eye with best correction or having</u>
- 9 a limitation of the field of vision such that the widest
- 10 diameter of the visual field subtends an angular distance not
- 11 greater than twenty degrees;
- 12 (ii) "visually impaired" means a prognosis of significantly
- 13 <u>deteriorating vision and either a visual acuity of no better</u>
- 14 than twenty/seventy vision in the better eye with best
- 15 <u>correction or a loss in the field of vision of fifty per cent or</u>
- 16 more.
- 17 Section 2. This act shall take effect in 60 days.
