## AN ACT

| 10                              | Section 1. Section 4 of the act of July 10, 1990 (P.L.404,   |
| 11                              | No.98), known as the Real Estate Appraisers Certification Act,   |
| 12                              | is amended to read:  |
| 13                              | Section 4. State Board of Certified Real Estate Appraisers.  |
| 14                              | (a) CreationThere is hereby created the State Board of   |
| 15                              | Certified Real Estate Appraisers as a departmental   |
| 16                              | administrative board in the Department of State. The board shall   |
| 17                              | consist of [seven] <u>nine</u> members who are citizens of the United  |
| 18                              | States and who have been residents of this Commonwealth for a  |
| 19                              | two-year period immediately prior to appointment, two of whom  |
| 20                              | shall be public members, [four] <u>five</u> of whom shall be persons   |

who are State-certified real estate appraisers, one of whom 1 shall be the Attorney General or his or her designee and one of 2 3 whom shall be the Secretary of the Commonwealth or his or her 4 designee. [For the initial board appointments, the four professional members need not be certified at the time of 5 appointment but shall have appropriate appraisal experience and 6 7 education and shall have demonstrated adherence to standards of professional practice.] 8

9 (b) Term of office.--The professional and public members 10 shall serve four-year terms[, except as provided in subsection 11 (c),] and shall be appointed by the Governor by and with the 12 advice and consent of a majority of the members elected to the 13 Senate.

14 [(c) Initial appointments.--Within 90 days of the effective 15 date of this act, the Governor shall nominate one professional 16 member to serve a four-year term; one public member and one 17 professional member to serve three-year terms; one public member 18 and one professional member to serve two-year terms; and one 19 professional member to serve a one-year term.]

20 (d) Continuation in office. -- Each professional and public member shall continue in office until a successor is duly 21 22 appointed and qualified but no longer than six months after the 23 expiration of the term. In the event that a board member shall 24 die, resign or otherwise become disqualified during the term of 25 office, a successor shall be appointed in the same way and with 26 the same qualifications as set forth in this section and shall 27 hold office for the unexpired portion of the unexpired term. 28 (e) Limit on terms. -- No board member shall be eliqible for 29 appointment to serve more than two consecutive four-year terms.

30 (f) Forfeiture of membership.--A board member who fails to 20030H0954B1120 - 2 - attend three consecutive meetings shall forfeit his or her seat
 unless the secretary, upon written request from the member,
 finds that the member should be excused from a meeting because
 of illness or the death of a family member.

5 (g) Compensation.--Each member of the board, except the 6 secretary, shall receive per diem compensation at the rate of 7 \$60 per diem when actually attending to the work of the board. 8 Members shall also receive reasonable traveling, hotel and other 9 necessary expenses incurred in the performance of their duties 10 in accordance with Commonwealth regulations.

11 (h) Forfeiture for nonattendance. -- A public member who fails to attend two consecutive statutorily mandated training seminars 12 13 in accordance with section 813(e) of the act of April 9, 1929 14 (P.L.177, No.175), known as The Administrative Code of 1929, 15 shall forfeit his or her seat unless the secretary, upon written 16 request from the public member, finds that the public member 17 should be excused from a meeting because of illness or the death 18 of a family member.

(i) Quorum.--A majority of the members of the board serving in accordance with law shall constitute a quorum for purposes of conducting the business of the board. A member may not be counted as part of a quorum or vote on any issue unless he or she is physically in attendance at the meeting.

24 (j) Meetings.--The board shall meet at least four times a 25 year in Harrisburg.

(k) Notice.--Reasonable notice of all meetings shall be
given in conformity with [the act of July 3, 1986 (P.L.388,
No.84), known as the Sunshine Act] <u>65 Pa.C.S. Ch. 7 (relating to</u>
<u>open meetings)</u>.

30 (1) Operating procedures.--The board shall [meet within 30 20030H0954B1120 - 3 - 1 days after the appointment of its initial members and] set up operating procedures and an application form for certifying 2 3 appraisers. It shall be the responsibility of the board to circulate these forms and educate the public to the requirements 4 5 of certification. No other board and no commission within the Bureau of Professional and Occupational Affairs shall be 6 responsible, in any manner, for the policies, procedures or 7 8 other substantive matters which are within the powers and duties of the board as set forth in this act. 9

(m) Election of officers.--The board shall elect annually
from its membership a chairman, a vice chairman and a secretary.
Section 2. This act shall take effect in 60 days.
