- 1 (a) Establishment of restricted account.--There is hereby
- 2 established in the General Fund a restricted account to be known
- 3 as the Corporation Bureau Restricted Account. This account shall
- 4 receive 30% of the amount received by the department under this
- 5 subchapter except for the fees collected under 13 Pa.C.S. §
- 6 9525(a)(1)(ii) (relating to fees). This account shall receive 5%
- 7 of the amount received by the department under section
- 8 9525(a)(1)(ii). The balance of the amount received by the
- 9 department under this subchapter shall be deposited in the
- 10 General Fund. Funds in the Corporation Bureau Restricted Account
- 11 shall be used solely for the operation of the Corporation Bureau
- 12 in the Department of State and for its modernization as may be
- 13 required for improved operations of the bureau[.] unless a
- 14 <u>surplus arises after two consecutive years, at which time the</u>
- 15 Secretary of State shall transfer any amount in excess of the
- 16 <u>bureau's budget into the General Fund. The Secretary of State</u>
- 17 shall transfer \$5,000,000 from the account to the General Fund
- 18 in fiscal year 2003-2004.
