AN ACT

Amending the act of March 20, 2003 (P.L. , No.1A), entitled 1 2 "An act to provide from the General Fund for the expenses of 3 the Executive, Legislative and Judicial Departments of the 4 Commonwealth, the public debt and for the public schools for 5 the fiscal year July 1, 2003, to June 30, 2004, for certain 6 institutions and organizations, and for the payment of bills 7 incurred and remaining unpaid at the close of the fiscal year 8 ending June 30, 2003; to provide appropriations from the 9 State Lottery Fund, the Energy Conservation and Assistance Fund, the Hazardous Material Response Fund, The State Stores 10 Fund, the Milk Marketing Fund, the Home Investment Trust 11 12 Fund, the Emergency Medical Services Operating Fund, the 13 Tuition Payment Fund, the Banking Department Fund, the 14 Firearm Records Check Fund, the Ben Franklin Technology 15 Development Authority Fund and the Tobacco Settlement Fund to 16 the Executive Department; to provide appropriations from the Judicial Computer System Augmentation Account to the Judicial 17 18 Department for the fiscal year July 1, 2003, to June 30, 19 2004; to provide appropriations from the Motor License Fund 20 for the fiscal year July 1, 2003, to June 30, 2004, for the proper operation of the several departments of the 21 22 Commonwealth and the Pennsylvania State Police authorized to 23 spend Motor License Fund moneys; to provide for the 24 appropriation of Federal funds to the Executive Department of 25 the Commonwealth and for the establishment of restricted receipt accounts for the fiscal year July 1, 2003, to June 26 27 30, 2004, and for the payment of bills remaining unpaid at the close of the fiscal year ending June 30, 2003; to provide 28 for the additional appropriation of Federal and State funds 29

from the General Fund, for the Executive Department of the 1 Commonwealth for the fiscal year July 1, 2002, to June 30, 2 2003, and for the payment of bills incurred and remaining 3 unpaid at the close of the fiscal year ending June 30, 2002; 4 5 and making a repeal," providing for an appropriation for 6 payments to county fairs. 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 9 Section 1. As much as relates to the State appropriation for county fairs in section 208 of the act of March 20, 2003 (P.L. 10 11 , No.1A) known as the General Appropriations Act of 2003, is 12 amended to read: 13 Section 208. Department of 14 Agriculture.--The following amounts 15 are appropriated to the Department of 16 Agriculture: Federal State * * * 17 18 For payments to county fairs. 19 [State appropriation..... 3,400,000] 20 State appropriation..... 4,400,000 21 * * * 2.2 Section 2. This act shall take effect July 1, 2003, or 23 immediately, whichever is later.
