AN ACT

- 1 Amending Title 34 (Game) of the Pennsylvania Consolidated
- Statutes, providing for the penalty for a felony violation of
- 3 the second degree.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Sections 905 and 925(b) of Title 34 of the
- 7 Pennsylvania Consolidated Statutes are amended to read:
- 8 § 905. Assaulting an officer.
- 9 A person who attempts to cause or causes bodily injury to an
- 10 officer making an arrest or investigation for a violation of
- 11 this title or performing any duties required by this title
- 12 commits a [misdemeanor] felony of the second degree.
- 13 § 925. Jurisdiction and penalties.
- 14 * * *

- 1 (b) Fines and penalties for violations. -- In addition to any
- 2 other requirements of this title, the following fines and
- 3 penalties shall be imposed for violations of this title:
- 4 (1) Felony of the second degree, not less than \$5,000
- 5 nor more than \$25,000 and may be sentenced to imprisonment up
- 6 to ten years.
- 7 [(1)] Misdemeanor of the first degree, not less
- 8 than \$2,000 nor more than \$10,000 and may be sentenced to
- 9 imprisonment up to six months.
- 10 (2) Misdemeanor of the second degree, not less than
- \$1,000 nor more than \$5,000 and may be sentenced to
- imprisonment up to six months.
- 13 (3) Misdemeanor of the third degree, not less than \$500
- nor more than \$2,500 and may be sentenced to imprisonment up
- 15 to six months.
- 16 (4) Summary offense of the first degree, \$800.
- 17 (5) Summary offense of the second degree, \$500.
- 18 (6) Summary offense of the third degree, \$300.
- 19 (7) Summary offense of the fourth degree, \$200.
- 20 (8) Summary offense of the fifth degree, \$100.
- 21 (9) Summary offense of the sixth degree, \$75.
- 22 (10) Summary offense of the seventh degree, \$50.
- 23 (11) Summary offense of the eighth degree, \$25.
- 24 In addition to the imposition of any fines, costs of prosecution
- 25 shall also be assessed pursuant to 42 Pa.C.S. §§ 1725.1
- 26 (relating to costs) and 3571 (relating to Commonwealth portion
- 27 of fines, etc.).

- 29 Section 2. This act shall take effect in 60 days.
