AN ACT

- 1 Authorizing the Department of Transportation to sell certain
- vehicles used by the department to municipalities.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Surplus
- 7 Vehicles for Municipalities Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Department." The Department of Transportation of the
- 13 Commonwealth.
- 14 "Secretary." The Secretary of Transportation of the
- 15 Commonwealth.

- 1 "Surplus vehicle." A vehicle that is owned by the Department
- 2 of Transportation and declared by the department as surplus or
- 3 unserviceable property.
- 4 Section 3. Surplus vehicles for municipalities.
- 5 (a) Municipality requests.--A municipality may request
- 6 assistance from the secretary to purchase surplus vehicles for
- 7 municipal use. The municipality must provide to the secretary
- 8 information about the type of vehicle requested and information
- 9 demonstrating both the urgent need for the vehicles and the
- 10 inability of the municipality to purchase or lease new or used
- 11 vehicles.
- 12 (b) Department review.--The department may sell surplus
- 13 vehicles to municipalities selected by the department after
- 14 reviewing their requests and available surplus vehicles. The
- 15 secretary shall determine the reasonable price of the surplus
- 16 vehicles.
- 17 Section 4. Effective date.
- 18 This act shall take effect in 60 days.
