AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania 2 Consolidated Statutes, further providing for relief.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Section 6108(a)(7) of Title 23 of the
- 6 Pennsylvania Consolidated Statutes is amended to read:
- 7 § 6108. Relief.
- 8 (a) General rule. -- The court may grant any protection order
- 9 or approve any consent agreement to bring about a cessation of
- 10 abuse of the plaintiff or minor children. The order or agreement
- 11 may include:
- 12 * * *
- 13 (7) Ordering the defendant to temporarily relinquish to
- the sheriff the defendant's weapons [which] whether or not
- the weapons have been used or been threatened to be used in
- an incident of abuse against the plaintiff or the minor

- 1 children and prohibiting the defendant from acquiring or
- 2 possessing any other weapons for the duration of the order
- and requiring the defendant to relinquish to the sheriff any
- 4 firearm license the defendant may possess. The court's order
- 5 <u>shall provide for a search of the defendant's premises and</u>
- 6 any other location the defendant's weapons are likely to be
- 7 <u>found.</u> The court's order shall provide for the return of the
- 8 weapons and any firearm license to the defendant subject to
- 9 any restrictions and conditions as the court shall deem
- appropriate to protect the plaintiff or minor children from
- 11 further abuse through the use of weapons. A copy of the
- 12 court's order shall be transmitted to the chief or head of
- the police force or police department of the municipality and
- 14 to the sheriff of the county of which the defendant is a
- 15 resident.

- 17 Section 2. The amendment of 23 Pa.C.S. § 6108(a)(7) shall
- 18 apply to petitions filed on or after the effective date of this
- 19 act.
- 20 Section 3. This act shall take effect in 60 days.
