1	Authorizing PROVIDING FOR submission of a question to the	<
2	electorate pertaining to incurring certain indebtedness; and	<
3	provisionally authorizing the incurring of debt AUTHORIZING	<
4	INCURRING INDEBTEDNESS for water and wastewater treatment	
5	projects.	

- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Short title.
- 9 This act shall be known and may be cited as the Water and
- 10 Wastewater Treatment Project Bond Act.
- 11 Section 2. Question of indebtedness.
- 12 (a) Authorization.--Pursuant to the provisions of section
- 13 7(a)(3) of Article VIII of the Constitution of Pennsylvania, the
- 14 question of incurring indebtedness of \$250,000,000 for grants
- 15 and loans for the acquisition, repair, construction,
- 16 reconstruction, rehabilitation, extension, expansion and

- 1 improvement of water and wastewater infrastructure, including
- 2 water supply and sewage treatment systems, shall be submitted to
- 3 the electors at the 2004 primary election.
- 4 (b) Certification. -- The Secretary of the Commonwealth shall
- 5 forthwith certify the question to the county boards of
- 6 elections.
- 7 (c) Question.--The question shall be in substantially the
- 8 following form:
- 9 Do you favor the incurring of indebtedness by the
- 10 Commonwealth in the amount of \$250,000,000 for use as
- grants and loans for construction, expansion or
- improvement of water and wastewater infrastructure,
- including water supply and sewage treatment systems?
- 14 (D) ELECTION PROCEDURE. -- THE ELECTION SHALL BE CONDUCTED IN <-
- 15 ACCORDANCE WITH THE ACT OF JUNE 3, 1937 (P.L.1333, NO.320),
- 16 KNOWN AS THE PENNSYLVANIA ELECTION CODE, EXCEPT THAT ANY TIME
- 17 LIMITS FOR ADVERTISING NOTICE RELATED TO THE QUESTION ARE HEREBY
- 18 WAIVED.
- 19 Section 3. Debt to be utilized for water and wastewater
- treatment projects.
- 21 If the question in section 2 is submitted to the electors and <
- 22 approved in accordance with law, the Commonwealth is authorized
- 23 to incur additional indebtedness, not to exceed \$250,000,000, to
- 24 finance grants and loans as hereafter provided by law.
- 25 PROCEEDS OF THE BORROWING, NOT TO EXCEED \$250,000,000, SHALL <-
- 26 BE USED FOR LOANS AND GRANTS FOR THE ACQUISITION, REPAIR,
- 27 CONSTRUCTION, EXPANSION, EXTENSION, RECONSTRUCTION,
- 28 REHABILITATION OR IMPROVEMENTS OF WATER SUPPLY AND WASTEWATER
- 29 INFRASTRUCTURE AS HEREAFTER PROVIDED BY LAW.
- 30 Section 4. Effective date.

1 This act shall take effect immediately.
