- Designating a certain bridge carrying SR 248 over Aquashicola 2 Creek in Palmerton Borough, Carbon County, as the Colonel 3 John Craig Memorial Bridge; DESIGNATING A BRIDGE OVER CHESTER CREEK IN WESTTOWN TOWNSHIP, CHESTER COUNTY, AS THE L. CHARLES 5 SCIPIONE BRIDGE; DESIGNATING A CERTAIN BRIDGE ON PENNSYLVANIA 6 ROUTE 45 IN NORTHUMBERLAND AND UNION COUNTIES AS THE JUDGE 7 HERBERT W. CUMMINGS/JUDGE HAROLD M. MCCLURE MEMORIAL BRIDGE; DESIGNATING THE BRIDGE ON WHICH MAIN STREET CROSSES TROUT 9 CREEK IN THE BOROUGH OF SLATINGTON, LEHIGH COUNTY, AS THE 10 GENERAL THOMAS R. MORGAN USMC BRIDGE; REDESIGNATING THE 11 BRIDGE OVER THE MONONGAHELA RIVER KNOWN AS THE CLAIRTON-12 GLASSPORT BRIDGE, DEPARTMENT OF TRANSPORTATION NO. 02-2038-13 0010-0140, WHICH CONNECTS THE CITY OF CLAIRTON TO THE BOROUGH 14 OF GLASSPORT IN ALLEGHENY COUNTY, AS THE SENATOR EDWARD P. 15 ZEMPRELLI BRIDGE; DESIGNATING A TRUCK INSPECTION STATION AT 4242 ARAMINGO AVENUE, CITY OF PHILADELPHIA, PHILADELPHIA 16 17 COUNTY, AS THE SGT. JEFFREY T. ZIERNICKI TRUCK INSPECTION 18 STATION; DESIGNATING A TRUCK INSPECTION STATION AT 9200 19 BARTRAM AVENUE, CITY OF PHILADELPHIA, PHILADELPHIA COUNTY, AS 20 THE SGT. JEFFREY T. ZIERNICKI TRUCK INSPECTION STATION; AND 21 MAKING A RELATED REPEAL.
- The General Assembly of the Commonwealth of Pennsylvania
- 23 hereby enacts as follows:

- 1 Section 1. Colonel John Craig Memorial Bridge.
- 2 (a) Findings.--The General Assembly finds and declares as
- 3 follows:
- 4 (1) Colonel John Craig will be remembered for his
- 5 devoted service to the 147th Pennsylvania Volunteers
- 6 throughout the Civil War.
- 7 (2) The distinguished contributions of Colonel Craig
- 8 reflect the spirit of a true servant to our Commonwealth.
- 9 (b) Designation.--The bridge carrying SR 248 over
- 10 Aquashicola Creek in Palmerton Borough, Carbon County, is
- 11 designated and shall be known as the Colonel John Craig Memorial
- 12 Bridge.
- 13 (c) Signs. -- The Department of Transportation shall erect and
- 14 maintain signs, which shall display the name of the bridge
- 15 designated in subsection (b), at each end of the bridge.
- 16 SECTION 2. L. CHARLES SCIPIONE BRIDGE.
- 17 (A) DESIGNATION.--THE BRIDGE OVER CHESTER CREEK ON SR 926 IN
- 18 WESTTOWN TOWNSHIP, CHESTER COUNTY, IS HEREBY DESIGNATED AND
- 19 SHALL BE KNOWN AS THE L. CHARLES SCIPIONE BRIDGE.
- 20 (B) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 21 MAINTAIN SIGNS, WHICH SHALL DISPLAY THE NAME OF THE BRIDGE
- 22 DESIGNATED IN SUBSECTION (A), AT EACH END OF THE BRIDGE.
- 23 SECTION 3. GENERAL THOMAS R. MORGAN USMC BRIDGE.
- 24 (A) DESIGNATION.--THE BRIDGE ON WHICH MAIN STREET (ROUTE
- 25 873) CROSSES TROUT CREEK, IN THE BOROUGH OF SLATINGTON, LEHIGH
- 26 COUNTY, IS HEREBY DESIGNATED AND SHALL BE KNOWN AS THE GENERAL
- 27 THOMAS R. MORGAN USMC BRIDGE.
- 28 (B) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT
- 29 SUITABLE MARKERS TO IMPLEMENT THIS SECTION.
- 30 SECTION 4. REDESIGNATING THE CLAIRTON-GLASSPORT BRIDGE AS

- 1 THE SENATOR EDWARD P. ZEMPRELLI BRIDGE.
- 2 (A) FINDINGS.--THE GENERAL ASSEMBLY OF THE COMMONWEALTH OF
- 3 PENNSYLVANIA FINDS AND DECLARES AS FOLLOWS:
- 4 SENATOR EDWARD P. ZEMPRELLI WILL BE HONORED FOR HIS 25
- 5 YEARS OF DEVOTED PUBLIC SERVICE TO THE RESIDENTS OF
- 6 ALLEGHENY COUNTY. AMONG HIS MANY ACHIEVEMENTS, SENATOR
- 7 ZEMPRELLI SERVED FIVE YEARS AS A STATE REPRESENTATIVE
- 8 PRIOR TO SERVING 20 YEARS AS A STATE SENATOR WHERE HE
- 9 SERVED AS BOTH MAJORITY LEADER AND MINORITY LEADER.
- 10 (B) REDESIGNATION.--THE BRIDGE OVER THE MONONGAHELA RIVER
- 11 KNOWN AS THE CLAIRTON-GLASSPORT BRIDGE, DEPARTMENT OF
- 12 TRANSPORTATION NO. 02-2038-0010-0140, CONNECTING THE CITY OF
- 13 CLAIRTON AND THE BOROUGH OF GLASSPORT, ALLEGHENY COUNTY, IS
- 14 HEREBY REDESIGNATED AS THE SENATOR EDWARD P. ZEMPRELLI BRIDGE.
- 15 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 16 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE BRIDGE
- 17 REDESIGNATED IN SUBSECTION (B) TO TRAFFIC IN BOTH DIRECTIONS ON
- 18 THE BRIDGE.
- 19 SECTION 5. SGT. JEFFREY T. ZIERNICKI TRUCK INSPECTION STATIONS.
- 20 (A) DESIGNATION. -- THE TRUCK INSPECTION STATIONS LOCATED AT
- 21 4242 ARAMINGO AVENUE, CITY OF PHILADELPHIA, PHILADELPHIA COUNTY,
- 22 AND AT 9200 BARTRAM AVENUE, CITY OF PHILADELPHIA, PHILADELPHIA
- 23 COUNTY, ARE DESIGNATED AND SHALL EACH BE KNOWN AS THE SGT.
- 24 JEFFREY T. ZIERNICKI TRUCK INSPECTION STATION.
- 25 (B) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 26 MAINTAIN SIGNS AT THE TRUCK INSPECTION STATIONS DESIGNATED IN
- 27 SUBSECTION (A) DISPLAYING THE NAME OF THE STATIONS.
- 28 SECTION 6. REPEAL.
- 29 SECTION 2 OF THE ACT OF DECEMBER 20, 1991 (P.L.398, NO.45),
- 30 ENTITLED, "AN ACT DESIGNATING A CERTAIN BRIDGE ON PENNSYLVANIA

- 1 ROUTE 45 IN NORTHUMBERLAND AND UNION COUNTIES AS THE JUDGE
- 2 HERBERT W. CUMMINGS/JUDGE HAROLD M. MCCLURE MEMORIAL BRIDGE; AND
- 3 DESIGNATING THE BRIDGE ON WHICH MAIN STREET CROSSES TROUT CREEK
