- 1 (b) The amount so designated by an individual on the income 2 tax return form shall be deducted from the tax refund to which 3 such individual is entitled and shall not constitute a charge against the income tax revenues due the Commonwealth. 4 5 (c) The department shall determine annually the total amount designated pursuant to this section, less reasonable 6 7 administrative costs, and shall report such amount to the State Treasurer who shall transfer such amount from the General Fund 8 9 to the Muscular Dystrophy Association.
- 10 Section 2. This act shall take effect in 60 days.
