INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, JULY 2, 2004

A RESOLUTION

- 1 Designating October 10, 2004, as "Tenth Amendment Day" in Pennsylvania.
- 3 WHEREAS, While Federal interests and initiatives continually
- 4 evolve, certain powers are reserved and rights guaranteed to
- 5 states and individuals under specific constitutional provisions;
- 6 and
- 7 WHEREAS, The Tenth Amendment to the Constitution of the
- 8 United States, also known as the States' Rights Amendment,
- 9 reads:
- 10 The powers not delegated to the United States by the
- 11 Constitution, nor prohibited by it to the States, are
- reserved to the States respectively, or to the people;
- 13 and
- 14 WHEREAS, This Constitutional amendment, the final amendment

- 1 in the Bill of Rights, was proposed by the Congress of the
- 2 United States on September 25, 1789, and ratified by the states
- 3 on December 15, 1791; and
- 4 WHEREAS, The Commonwealth has asserted its sovereignty under
- 5 the Tenth Amendment over all powers not otherwise enumerated or
- 6 granted to the Federal Government by the Constitution of the
- 7 United States, such as education and local government; and
- 8 WHEREAS, The Commonwealth retains authority over its
- 9 legislative and regulatory processes in exercising these
- 10 reserved powers and shares certain powers with the Federal
- 11 Government; and
- 12 WHEREAS, The Commonwealth opposes the imposition of Federal
- 13 mandates which are beyond the scope of constitutionally
- 14 delegated powers; therefore be it
- 15 RESOLVED, That the House of Representatives designate October
- 16 10, 2004, as "Tenth Amendment Day" in Pennsylvania, setting
- 17 aside the tenth day of the tenth month to celebrate the
- 18 importance of the Tenth Amendment to the Constitution of the
- 19 United States in shaping the governmental, political and
- 20 administrative systems of this Commonwealth.
