AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- 2 act relating to the public school system, including certain
- 3 provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- 5 laws relating thereto, "further providing for State Report
- 6 Card.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 220 of the act of March 10, 1949 (P.L.30,
- 10 No.14), known as the Public School Code of 1949, amended or
- 11 added December 9, 2002 (P.L.1317, No.153) and December 23, 2003
- 12 (P.L.304, No.48), is amended to read:
- 13 Section 220. State Report Card. -- (a) The department shall
- 14 create a State Report Card based on the information collected
- 15 pursuant to this section. The department:
- 16 (1) Shall inform the public of the availability of the State
- 17 Report Card prior to publication.
- 18 (2) Shall publish on its World Wide Web site the State
- 19 Report Card, providing information at the State, local education

- 1 agency and school levels. The State Report Card shall include
- 2 all of the following:
- 3 (i) Information regarding the number of schools and school
- 4 <u>districts that have achieved adequate yearly progress and the</u>
- 5 <u>number of schools and school districts that have not achieved</u>
- 6 <u>adequate yearly progress</u>.
- 7 (ii) Information regarding the number of schools and school
- 8 districts that have achieved each academic performance target
- 9 and the number of schools and school districts that have not
- 10 <u>achieved each academic performance target.</u>
- 11 (iii) Information regarding the number of schools and school
- 12 districts in which more than five percent (5%) of the students
- 13 to whom the PSSA test was administered were enrolled in the
- 14 school district for less than two (2) school years as of the day
- 15 on which the PSSA test was administered.
- 16 (iv) Information regarding the number of schools and school
- 17 districts identified under subparagraph (iii) that have achieved
- 18 each academic performance target and the number of schools and
- 19 school districts that have not achieved each academic
- 20 performance target. For the purposes of this subparagraph,
- 21 achievement of the academic performance target shall be
- 22 calculated by excluding the PSSA test score of any student who
- 23 was enrolled in the school district for less than two (2) school
- 24 years as of the day on which the PSSA test was administered.
- 25 <u>(v) Information regarding the number of schools and school</u>
- 26 districts in which more than five percent (5%) of the students
- 27 to whom the PSSA test was administered were classified as
- 28 <u>limited English proficient as of the day on which the PSSA test</u>
- 29 <u>was administered</u>.
- 30 (vi) Information regarding the number of schools and school

- 1 districts identified under subparagraph (v) that have achieved
- 2 <u>each academic performance target and the number of schools and</u>
- 3 school districts that have not achieved each academic
- 4 performance target. For the purposes of this subparagraph,
- 5 achievement of the academic performance target shall be
- 6 calculated by excluding the PSSA test score of any student who
- 7 was classified as limited English proficient as of the day on
- 8 which the PSSA test was administered.
- 9 <u>(vii) Information regarding the number of schools and school</u> <---
- 10 districts in which more than sixteen percent (16%) of the
- 11 students to whom the PSSA test was administered were classified
- 12 as a student with a disability as of the day on which the PSSA
- 13 <u>test was administered</u>.
- 14 (viii) Information regarding:
- 15 (A) The number of schools and school districts identified
- 16 <u>under subparagraph (v) that have achieved each academic</u>
- 17 performance target; and
- 18 (B) The number of schools and school districts that have not
- 19 achieved each academic performance target. For the purposes of
- 20 this subparagraph, calculation of the achievement of the
- 21 <u>academic performance target shall exclude the PSSA test score of</u>
- 22 any student who was classified as a student with a disability as
- 23 of the day on which the PSSA test was administered.
- 24 (VII) INFORMATION REGARDING THE NUMBER OF SCHOOLS AND SCHOOL
- 25 DISTRICTS IN WHICH MORE THAN SIXTEEN PERCENT (16%) OF THE
- 26 STUDENTS TO WHOM THE PSSA TEST WAS ADMINISTERED WERE CLASSIFIED
- 27 AS STUDENTS WITH A DISABILITY AS OF THE DAY ON WHICH THE PSSA
- 28 TEST WAS ADMINISTERED.
- 29 (VIII) INFORMATION REGARDING THE NUMBER OF SCHOOLS AND
- 30 SCHOOL DISTRICTS IDENTIFIED UNDER SUBPARAGRAPH (VII) THAT HAVE

- 1 ACHIEVED EACH ACADEMIC PERFORMANCE TARGET AND THE NUMBER OF
- 2 SCHOOLS AND SCHOOL DISTRICTS THAT HAVE NOT ACHIEVED EACH
- 3 ACADEMIC PERFORMANCE TARGET. FOR THE PURPOSES OF THIS
- 4 SUBPARAGRAPH, ACHIEVEMENT OF THE ACADEMIC PERFORMANCE TARGET
- 5 SHALL BE CALCULATED BY EXCLUDING THE PSSA TEST SCORE OF ANY
- 6 STUDENT WHO WAS CLASSIFIED AS A STUDENT WITH A DISABILITY AS OF
- 7 THE DAY ON WHICH THE PSSA TEST WAS ADMINISTERED.
- 8 (3) Shall issue guidelines concerning the collection and
- 9 submission of data as necessary to ensure continued compliance
- 10 with Federal and State laws, regulations and standards.
- 11 (4) May conduct audits of the data submitted by local
- 12 education agencies under subsection (b) for the purpose of
- 13 assuring accuracy and completeness. If the department determines
- 14 to conduct audits under this paragraph, the department shall
- 15 issue guidelines for the conduct of such audits, including the
- 16 percentage of local education agencies to be audited on a yearly
- 17 basis. In conducting such audits, the department shall
- 18 coordinate with the Department of the Auditor General. Nothing
- 19 in this section shall be construed to expand the auditing
- 20 authority of the Auditor General.
- 21 (b) A local education agency shall do all of the following:
- 22 (1) Collect data and submit it in a form and manner
- 23 prescribed by the department. The data shall include:
- 24 (i) The information described in section 1111(h)(1)(C) of
- 25 the No Child Left Behind Act of 2001 as applied to the local
- 26 education agency as a whole and to each of its schools.
- 27 (ii) The information described in section 1111(h)(2)(B)(i)
- 28 and (ii) of the No Child Left Behind Act of 2001.
- 29 (iii) Any other information required to comply with the No
- 30 Child Left Behind Act of 2001.

- 1 (iv) Any information described in 22 Pa. Code § 4.61
- 2 (relating to school profiles) that is not included under
- 3 subparagraph (i), (ii) or (iii).
- 4 (v) Information on the number of students to whom the PSSA
- 5 test was administered who were enrolled in the school district
- 6 for less than two (2) school years as of the day on which the
- 7 PSSA test was administered.
- 8 (vi) Information on the number of students to whom the PSSA
- 9 <u>test was administered who were classified as limited English</u>
- 10 proficient as of the day on which the PSSA test was
- 11 administered.
- 12 (vii) Information on the number of students to whom the PSSA
- 13 <u>test was administered who were classified as a student STUDENTS</u>
- 14 with a disability as of the day on which the PSSA test was
- 15 administered.
- 16 (2) Disseminate the information collected in paragraph (1)
- 17 in accordance with the public dissemination requirements of
- 18 section 1111(h)(2)(E) of the No Child Left Behind Act of 2001.
- 19 Nothing in this section shall excuse a local education agency
- 20 from complying with the requirements of the No Child Left Behind
- 21 Act of 2001 not specifically referenced in this section.
- 22 (c) Definitions.--As used in this section, the following
- 23 words and phrases shall have the meanings given to them in this
- 24 subsection:
- 25 "Department." The Department of Education of the
- 26 Commonwealth.
- 27 "Local education agency." A school district, cyber charter
- 28 school, charter school, area vocational-technical school or
- 29 intermediate unit.
- 30 Section 2. This act shall take effect in 60 days.
