## AN ACT

- Providing for the continuation of the Pennsylvania Senior
- 2
- Environment Corps volunteer program administered by the Department of Environmental Protection and the Department of 3
- 4 Aging; and making an appropriation.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- Section 1. Short title.
- 8 This act shall be known and may be cited as the Pennsylvania
- Senior Environment Corps Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Departments." The Department of Environmental Protection
- 15 and the Department of Aging of the Commonwealth.
- 16 "Pennsylvania Senior Environment Corps." The established
- 17 Statewide network of county-based host organizations for older
- Pennsylvanians who implement environmental, educational, social 18

- 1 and health programs benefiting their communities and the
- 2 Commonwealth, and additional host organizations in counties not
- 3 yet served, as appropriate.
- 4 Section 3. Declaration of policy.
- 5 The General Assembly finds and declares as follows:
- 6 (1) Pennsylvania has an active, talented and informed
- 7 population of older residents who seek out activities and
- 8 programs which contribute to the improvement of communities
- 9 and individuals.
- 10 (2) Since 1997 the more than 20,000 active members of
- 11 the Pennsylvania Senior Environment Corps have used their
- 12 expertise and interest in protecting the environment to
- 13 pursue projects related to water quality monitoring,
- 14 environmental education, restoration and protection of our
- 15 environment and homeland security.
- 16 (3) The Pennsylvania Senior Environment Corps program
- has been recognized by the United Nations, Renew America and
- other organizations as an innovative and unique program
- 19 involving older citizens in creative ways to improve the
- 20 environment and has been copied by many other states and
- 21 countries around the world.
- 22 (4) Continuation and expansion of the Pennsylvania
- 23 Senior Environment Corps provides older citizens with
- 24 effective opportunities to be involved in positive activities
- 25 that not only contribute to the protection and restoration of
- 26 Pennsylvania's environment, but provide significant benefits
- 27 to those involved with this program.
- 28 Section 4. Pennsylvania Senior Environment Corps.
- 29 (a) Continued support. -- The departments shall continue
- 30 funding and support and jointly administer the Pennsylvania

- 1 Senior Environment Corps and its network of chapters throughout
- 2 this Commonwealth for the purpose of maintaining and expanding
- 3 opportunities for this Commonwealth's older citizens to be
- 4 involved in volunteer projects relating to water quality
- 5 monitoring, environmental education, restoration and protection
- 6 of the environment and homeland security.
- 7 (b) Program components.--The Pennsylvania Senior Environment
- 8 Corps program shall include components that provide support for:
- 9 (1) Equipment and supplies required for successful
- 10 programs.
- 11 (2) Networking and recognition opportunities.
- 12 (3) Training required for successful program
- implementation.
- 14 (4) Coordination and documentation, including by
- 15 electronic means, of program activities.
- 16 (5) Reimbursement of the volunteers and their host
- organizations for direct program expenses that support
- 18 successful recruitment and mobilization of the volunteers.
- 19 (6) Public education about the vitality and value of
- this Commonwealth's older citizens.
- 21 Section 5. Reporting requirements.
- 22 (a) Annual report. -- The departments shall provide to the
- 23 General Assembly an annual report on the Pennsylvania Senior
- 24 Environment Corps program which includes information on:
- 25 (1) the impact of the Pennsylvania Senior Environment
- 26 Corps on the achievement of the missions of the departments;
- 27 (2) the cost-effectiveness of the Pennsylvania Senior
- 28 Environment Corps activities;
- 29 (3) the staff support of the departments for the
- 30 Pennsylvania Senior Environment Corps;

- 1 (4) the State, regional and local partnerships
- 2 established by the departments and the Pennsylvania Senior
- 3 Environment Corps for the purpose of advancing departmental
- 4 missions and the success of the Pennsylvania Senior
- 5 Environment Corps; and
- 6 (5) projections for future volunteer engagement in the
- 7 Pennsylvania Senior Environment Corps, its programs and the
- 8 betterment of this Commonwealth's quality of life.
- 9 (b) Meeting with secretaries.--Representatives of the
- 10 Pennsylvania Senior Environment Corps program shall meet twice a
- 11 year with the secretaries of the departments to provide
- 12 information on accomplishments and challenges of the
- 13 Pennsylvania Senior Environment Corps program.
- 14 Section 6. Appropriation.
- The sum of \$350,000 is hereby appropriated, in equal parts,
- 16 to the Department of Environmental Protection and the Department
- 17 of Aging for the fiscal year July 1, 2004, to June 30, 2005, to
- 18 support the Pennsylvania Senior Environment Corps program.
- 19 Section 7. Effective date.
- This act shall take effect July 1, 2004.
