- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated 2 Statutes, providing for operation of motor-driven cycles and 3 motorized pedalcycles in cities of the first class; and further providing for operation of snowmobiles and all-5 terrain vehicles on streets and highways. 6 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 Section 1. - 6 (a) General rule.--Except as set forth in subsection (b), an
- 7 individual who violates this subchapter commits a summary
- 8 offense and shall, upon conviction, be sentenced to pay a fine
- 9 of \$300 or to imprisonment for not more than 90 days, or both.
- 10 (b) Subsequent offenses.--An individual who, after being
- 11 sentenced under subsection (a), violates this subchapter commits
- 12 a misdemeanor of the third degree and shall, upon conviction, be
- 13 sentenced to pay a fine of \$2,500 or to imprisonment for not
- 14 more than one year, or both.

- 18 (a) General rule. -- Except as otherwise provided in this
- 19 chapter, it is unlawful to [operate] do any of the following:

- highway which is not designated and posted as a snowmobile or

- 27 (d) Penalty.--
- 28 (1) Except as set forth in paragraph (2), an individual
- who violates subsection (a)(1) commits a summary offense and
- 30 shall, upon conviction, be sentenced to pay a fine of \$300 or

- 1 to imprisonment for not more than 90 days, or both.
- (2) An individual who, after being sentenced under 2
- paragraph (1), violates subsection (a)(1) commits a 3
- misdemeanor of the third degree and shall, upon conviction, 4
- 5 be sentenced to pay a fine of \$2,500 or to imprisonment for
- 6 not more than one year, or both.
- Section 3. This act shall take effect in 180 days. 7
