AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, further providing for drug-free zones;
- 3 and making an appropriation.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 6317 heading and (a) of Title 18 of the
- 7 Pennsylvania Consolidated Statutes are amended and the section
- 8 is amended by adding subsections to read:
- 9 § 6317. Drug-free [school] zones.
- 10 (a) General rule. -- A person 18 years of age or older who is
- 11 convicted in any court of this Commonwealth of a violation of
- 12 section 13(a)(14) or (30) of the act of April 14, 1972 (P.L.233,
- 13 No.64), known as The Controlled Substance, Drug, Device and
- 14 Cosmetic Act, shall, if the delivery or possession with intent
- 15 to deliver of the controlled substance occurred within 1,000
- 16 feet of the real property on which is located a public, private

- 1 or parochial school or a college or university or a child day-
- 2 care center or within 250 feet of the real property on which is
- 3 located a recreation center or playground or on a school bus, be
- 4 sentenced to a minimum sentence of at least two years of total
- 5 confinement, notwithstanding any other provision of this title,
- 6 The Controlled Substance, Drug, Device and Cosmetic Act or other
- 7 statute to the contrary. The maximum term of imprisonment shall
- 8 be four years for any offense:
- 9 (1) subject to this section; and
- 10 (2) for which The Controlled Substance, Drug, Device and
- 11 Cosmetic Act provides for a maximum term of imprisonment of
- 12 less than four years.
- 13 If the sentencing court finds that the delivery or possession
- 14 with intent to deliver was to an individual under 18 years of
- 15 age, then this section shall not be applicable and the offense
- 16 shall be subject to section 6314 (relating to sentencing and
- 17 penalties for trafficking drugs to minors).
- 18 * * *
- 19 (e) Notice requirement. -- A day-care center shall post
- 20 conspicuously on the premises a notice stating that:
- 21 <u>(1) The premises is a day-care center.</u>
- 22 (2) The premises is a drug-free zone.
- 23 (f) Definitions.--As used in this section, the following
- 24 words and phrases shall have the meanings given to them in this
- 25 subsection:
- 26 "Child day care." Care in lieu of parental care given for
- 27 part of the 24-hour day to children under 16 years of age, away
- 28 from their own homes, but does not include child day care
- 29 <u>furnished in places of worship during religious services.</u>
- 30 <u>"Child day-care center."</u> Any premises operated for profit in

- 1 which child day care is provided simultaneously for seven or
- 2 more children who are not relatives of the operator, except such
- 3 <u>centers operated under social service auspices.</u>
- 4 Section 2. To promote the prevention of prostitution and
- 5 other offenses under 18 Pa.C.S., the sum of \$10,000,000 is
- 6 hereby appropriated to the Pennsylvania Commission on Crime and
- 7 Delinquency for the fiscal year July 1, 2005, to June 30, 2006,
- 8 for competitive grants to local law enforcement agencies and to
- 9 the Pennsylvania State Police to carry out the provisions of
- 10 this act and to prevent the occurrence or apprehend persons who
- 11 commit offenses under 18 Pa.C.S. At least \$3,000,000 of this
- 12 appropriation shall be allocated to police departments with ten
- 13 or fewer police officers.
- 14 Section 3. This act shall take effect in 60 days.
