AN ACT

- 1 Providing for recruitment and retention of nurses; establishing
- 2 the Pennsylvania Center for Nursing; and making an
- 3 appropriation.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Nurse
- 8 Recruitment and Retention Act.
- 9 Section 2. Declaration of policy.
- 10 The General Assembly finds and declares as follows:
- 11 (1) The center will repay the Commonwealth's investment

- 1 by providing an ongoing strategy for the allocation of the
- 2 Commonwealth's resources directed toward nursing.
- 3 (2) It is imperative that the Commonwealth protect its
- 4 investment and progress made in its nursing efforts to date.
- 5 The center is the appropriate means to do this.
- 6 (3) The center shall have adequate budget support for
- 7 its operations so that it may have adequate resources to
- 8 carry out this act.
- 9 Section 3. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Board." The Pennsylvania Center for Nursing Board of
- 14 Directors.
- 15 "Center." The Pennsylvania Center for Nursing established in
- 16 section 4 (relating to Pennsylvania Center for Nursing).
- 17 Section 4. Pennsylvania Center for Nursing.
- 18 (a) Establishment.--The Pennsylvania Center for Nursing is
- 19 established as a legislative agency.
- 20 (b) Powers and duties.--The center has the following powers
- 21 and duties:
- 22 (1) To address issues of supply and demand of the
- 23 nursing work force in this Commonwealth. This paragraph
- includes education, recruitment, retention and utilization of
- 25 nurse personnel resources.
- 26 (2) To develop a Statewide nursing work force consortium
- 27 among schools, health care providers and other relevant
- institutions to plan and implement models which enhance
- 29 educational and career mobility for nurses.
- 30 (3) To establish a mechanism to maintain the consortium

1	under paragraph (2) on a long-term basis so the monitoring of
2	nursing care needs and the building of a nursing work force
3	with corresponding strengths become ongoing components of
4	this Commonwealth's health care structure as follows:
5	(i) Conduct a comprehensive assessment of the
6	current and projected nursing care needs in this
7	Commonwealth.
8	(ii) Develop a dependable system for estimating
9	future needs.
10	(iii) Analyze the capacity of this Commonwealth's
11	nursing work force to meet these needs.
12	(iv) Analyze the area's educational infrastructure
13	to produce the numbers and types of nursing professionals
14	required.
15	(v) Convene various groups representative of nurses,
16	other health care providers, business and industry,
17	consumers, legislators and educators to do all of the
18	following:
19	(A) Review and comment on data analysis
20	conducted by the center.
21	(B) Recommend systemic changes, needed to
22	improve delivery of health care services by nurses,
23	including strategies for implementation of
24	recommended changes.
25	(C) Evaluate and report the results of these
26	efforts to the General Assembly and others.
27	(D) Promote media and positive image-building
28	efforts for nursing.
29	(E) Report with evidenced-based data the
30	relationship of nursing care to the positive outcomes

- of the health consumer.
- 2 (c) Director. -- The center shall be operated by a director
- 3 employed by the board under section 5(f)(4) (relating to board
- 4 of directors).
- 5 Section 5. Board of directors.
- 6 (a) Establishment.--The center shall be governed by a board
- 7 of directors.
- 8 (b) Membership.--The board shall consist of the following
- 9 directors:
- 10 (1) Four directors appointed by the President pro
- 11 tempore of the Senate as follows:
- 12 (i) One director must be a professional registered
- 13 nurse.
- 14 (ii) One director must be a representative of the
- 15 hospital industry.
- 16 (iii) The remaining directors must represent other
- 17 health care professions, business, industry, health care
- 18 providers or consumers.
- 19 (2) Four directors appointed by the Speaker of the House
- of Representatives as follows:
- 21 (i) One director must be a professional registered
- 22 nurse.
- 23 (ii) One director must be a representative of the
- long-term care industry.
- 25 (iii) The remaining directors must represent other
- health care professions, business, industry, health care
- 27 providers or consumers.
- 28 (3) Three directors appointed by the Governor as
- 29 follows:
- 30 (i) Two directors must be professional registered

1 nurses. (ii) One director must be a representative of the 2 3 home health care industry. 4 (4) Four directors appointed by the Governor as follows: 5 (i) All directors must be nurse educators. (ii) One director must have experience in the 6 development and implementation of a diploma school of 7 8 nursing. (iii) One director must have experience in the 9 10 development and implementation of an associate degree 11 nursing program. 12 (iv) One director must have experience in the 13 development and implementation of a baccalaureate degree 14 nursing program. 15 (v) One director must have experience in the 16 development and implementation of a practical nursing 17 program. 18 (c) Terms.--(1) Directors under subsection (b)(1) and (2) shall 19 20 serve at the pleasure of the appointing authority and may not 21 serve consecutively for more than eight years. (2) Directors under subsection (b)(3) shall serve as 22 23 follows: 24 (i) One director shall serve an initial term of four 25 years. 26 (ii) One director shall serve an initial term of 27 three years. 28 (iii) One director shall serve initial terms of two 29 years. 30 Each term following an initial term shall be

- 2 (v) A director under this paragraph may not serve
- 3 more than two terms consecutively.
- 4 (3) Directors under subsection (b)(4) shall serve as
- 5 follows:
- 6 (i) One director shall serve an initial term of four
- years.
- 8 (ii) One director shall serve an initial term of
- 9 three years.
- 10 (iii) Two directors shall serve an initial term of
- 11 two years.
- 12 (iv) Each term following an initial term shall be
- for four years.
- 14 (v) A director under this paragraph may not serve
- more than two terms consecutively.
- 16 (4) A vacancy under subsection (b)(3) or (4) shall be
- filled by the appointing authority for the remainder of the
- 18 term.
- 19 (5) A director shall hold office until a successor is
- 20 appointed and qualified.
- 21 (d) Quorum. -- Eight directors constitute a quorum.
- 22 (e) Officers.--The directors shall elect a chairperson and
- 23 secretary from among its members. An officer shall serve a term
- 24 of two years. An officer may not serve successive terms.
- 25 (f) Powers and duties. -- The board has the following powers
- 26 and duties:
- 27 (1) To determine operational policy for the center.
- 28 (2) To implement the functions of the center.
- 29 (3) To seek and accept private funds to carry out the
- 30 operations of the center.

- 1 (4) To employ an executive director of the center.
- 2 (5) To establish committees as necessary.
- 3 (6) To appoint a multidisciplinary advisory council for
- 4 input and advice on policy matters.
- 5 (q) Compensation. -- Directors shall serve without
- 6 compensation but shall be reimbursed for reasonable and
- 7 necessary expenses in the performance of their duties.
- 8 Section 19. Appropriation.
- 9 The sum of \$, or as much thereof as may be necessary,
- 10 is hereby appropriated to the Pennsylvania Center for Nursing
- 11 for the fiscal year July 1, 2005, to June 30, 2006, to carry out
- 12 the provisions of this act.
- 13 Section 20. Effective date.
- 14 This act shall take effect in 60 days.
