AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 2 act relating to the public school system, including certain provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto, " providing for adjustments based on Consumer Price Index; and further providing for work to be done under contract let on bids, for purchase of supplies, for contracts for construction, repair, renovation or 8 9 maintenance, for project contracts and for powers and duties 10 of institution presidents. 11 The General Assembly of the Commonwealth of Pennsylvania 12 hereby enacts as follows: Section 1. The act of March 10, 1949 (P.L.30, No.14), known 13 as the Public School Code of 1949, is amended by adding a 14 15 section to read: 16 Section 116. Adjustments Based on Consumer Price Index. -- (a) 17 (1) The Department of Labor and Industry shall determine the 18 percentage change in the Consumer Price Index for All Urban Consumers for the twelve-month period ending September 30 of the 19 calendar year in which this subsection becomes effective, and 20

- 1 for each successive twelve-month period thereafter.
- 2 (2) The amounts at which competitive bidding or written or
- 3 <u>telephonic price quotations are required under this act shall be</u>
- 4 <u>adjusted annually as follows:</u>
- 5 (i) In the case of competitive bidding, the positive
- 6 percentage change, as determined in accordance with clause (1),
- 7 shall be multiplied by the amount applicable under the provision
- 8 requiring competitive bidding for the current year and the
- 9 product thereof shall be added to the amount applicable under
- 10 the provision requiring competitive bidding for the current
- 11 year, with the result rounded to the nearest multiple of ten
- 12 <u>dollars (\$10)</u>.
- 13 (ii) In the case of written or telephonic price quotations,
- 14 the positive percentage change, as determined in accordance with
- 15 <u>clause (1), shall be multiplied by the amount applicable under</u>
- 16 <u>the provision requiring written or telephonic price quotations</u>
- 17 for the current year and the product thereof shall be added to
- 18 the amount applicable under the provision requiring written or
- 19 telephonic price quotations for the current year, with the
- 20 result rounded to the nearest multiple of ten dollars (\$10).
- 21 (3) The annual determination required under clause (1) and
- 22 the calculation of the adjustments required under clause (2)
- 23 shall be made in the period between October 1 and November 15 of
- 24 the year following the effective date of this subsection, and
- 25 <u>annually between October 1 and November 15 of each successive</u>
- 26 year.
- 27 (4) The adjusted amounts obtained in accordance with clause
- 28 (2) shall become effective January 1 for the calendar year
- 29 following the year in which the determination required under
- 30 clause (1) is made.

- 1 (5) The Department of Labor and Industry shall give notice
- 2 <u>in the Pennsylvania Bulletin prior to January 1 of each calendar</u>
- 3 year of the annual percentage change determined in accordance
- 4 with clause (1) and the amounts, whether adjusted or unadjusted
- 5 in accordance with clause (2), at which competitive bidding or
- 6 written or telephonic price quotations are required for the
- 7 <u>calendar year beginning the first day of January after</u>
- 8 publication of the notice.
- 9 Section 2. Section 751(a), (a.1), (b) and (f) of the act,
- 10 amended or added July 13, 1979 (P.L.94, No.41) and May 4, 1990
- 11 (P.L.164, No.38), are amended to read:
- 12 Section 751. Work to be Done Under Contract Let on Bids;
- 13 Exception. -- (a) All construction, reconstruction, repairs,
- 14 maintenance or work of any nature, including the introduction of
- 15 plumbing, heating and ventilating, or lighting systems, upon any
- 16 school building or upon any school property, or upon any
- 17 building or portion of a building leased under the provisions of
- 18 section 703.1, made by any school district, where the entire
- 19 cost, value, or amount of such construction, reconstruction,
- 20 repairs, maintenance or work, including labor and material,
- 21 shall exceed [ten thousand dollars (\$10,000)] twenty-five
- 22 thousand dollars (\$25,000) subject to annual adjustment under
- 23 <u>section 116</u>, shall be done under separate contracts to be
- 24 entered into by such school district with the lowest responsible
- 25 bidder, upon proper terms, after due public notice has been
- 26 given asking for competitive bids. Whenever a board of school
- 27 directors shall approve the use of a prefabricated unit,
- 28 complete in itself, for a school building or other proper
- 29 structure to be erected upon school property, the board of
- 30 school directors may have prepared appropriate specifications

- 1 detailing the size and material desired in a particular
- 2 prefabricated unit, including all utilities such as plumbing,
- 3 heating and ventilating, and electrical work, and may advertise
- 4 for a single bid on all the work and award the contract therefor
- 5 to the lowest responsible bidder: Provided, That if due to an
- 6 emergency a school plant or any part thereof becomes unusable
- 7 competitive bids for repairs or replacement may be solicited
- 8 from at least three responsible bidders, and upon the approval
- 9 of any of these bids by the Secretary of Education, the board of
- 10 school directors may proceed at once to make the necessary
- 11 repairs or replacements in accordance with the terms of said
- 12 approved bid or bids.
- 13 (a.1) Written or telephonic price quotations from at least
- 14 three qualified and responsible contractors shall be requested
- 15 by the board of school directors for all contracts that exceed
- 16 [four thousand dollars (\$4,000)] ten thousand dollars (\$10,000)
- 17 <u>subject to annual adjustment under section 116</u> but are less than
- 18 the amount requiring advertisement and competitive bidding, or,
- 19 in lieu of price quotations, a memorandum shall be kept on file
- 20 showing that fewer than three qualified contractors exist in the
- 21 market area within which it is practicable to obtain quotations.
- 22 A written record of telephonic price quotations shall be made
- 23 and shall contain at least the date of the quotation, the name
- 24 of the contractor and the contractor's representative, the
- 25 construction, reconstruction, repair, maintenance or work which
- 26 was the subject of the quotation and the price. Written price
- 27 quotations, written records of telephonic price quotations and
- 28 memoranda shall be retained for a period of three years.
- 29 (b) The board of school directors in any school district may
- 30 perform any construction, reconstruction, repairs, or work of

- 1 any nature, where the entire cost or value, including labor and
- 2 material, is less than [five thousand dollars (\$5000)] ten
- 3 thousand dollars (\$10,000) subject to annual adjustment under
- 4 section 116, by its own maintenance personnel. The board of
- 5 school directors in any school district may authorize the
- 6 secretary of the board or other executive to award contracts for
- 7 construction, reconstruction, repairs, or work of any nature,
- 8 where the entire cost or value, including labor and material,
- 9 [is ten thousand dollars (\$10,000)] <u>subject to annual adjustment</u>
- 10 under section 116, is twenty-five thousand dollars (\$25,000) or
- 11 less, without soliciting competitive bids, subject, however, to
- 12 the provisions of subsection (a.1).
- 13 * * *
- 14 (f) No board of school directors shall evade the provisions
- 15 of this section as to advertising for bids or purchasing
- 16 materials or contracting for services piecemeal for the purpose
- 17 of obtaining prices under [ten thousand dollars (\$10,000)]
- 18 twenty-five thousand dollars (\$25,000) subject to annual
- 19 adjustment under section 116, upon transactions which should, in
- 20 the exercise of reasonable discretion and prudence, be conducted
- 21 as one transaction amounting to more than [ten thousand dollars
- 22 (\$10,000)] twenty-five thousand dollars (\$25,000) subject to
- 23 <u>annual adjustment under section 116</u>. This provision is intended
- 24 to make unlawful the practice of evading advertising
- 25 requirements by making a series of purchases or contracts each
- 26 for less than the advertising requirement price, or by making
- 27 several simultaneous purchases or contracts each below said
- 28 price, when in either case the transaction involved should have
- 29 been made as one transaction for one price.
- 30 Section 3. Section 807.1 of the act, amended May 4, 1990

- 1 (P.L.164, No.38), is amended to read:
- 2 Section 807.1. Purchase of Supplies.--(a) All furniture,
- 3 equipment, textbooks, school supplies and other appliances for
- 4 the use of the public schools, costing [ten thousand dollars
- 5 (\$10,000)], subject to annual adjustment under section 116,
- 6 twenty-five thousand dollars (\$25,000) or more shall be
- 7 purchased by the board of school directors only after due
- 8 advertisement as hereinafter provided. Supplies, subject to
- 9 <u>annual adjustment under section 116</u>, costing [ten thousand
- 10 dollars (\$10,000)] twenty-five thousand dollars (\$25,000) or
- 11 more shall be purchased by the board of school directors only
- 12 after public notice has been given by advertisement once a week
- 13 for three (3) weeks in not less than two (2) newspapers of
- 14 general circulation. In any district where no newspaper is
- 15 published, said notice may, in lieu of such publication, be
- 16 posted in at least five (5) public places.
- 17 (a.1) Written or telephonic price quotations from at least
- 18 three qualified and responsible vendors shall be requested by
- 19 the board of school directors for all purchases of supplies that
- 20 exceed [four thousand dollars (\$4,000)] ten thousand dollars
- 21 (\$10,000), subject to annual adjustment under section 116, but
- 22 are less than the amount requiring advertisement and competitive
- 23 bidding, or, in lieu of price quotations, a memorandum shall be
- 24 kept on file showing that fewer than three qualified vendors
- 25 exist in the market area within which it is practicable to
- 26 obtain quotations. A written record of telephonic price
- 27 quotations shall be made and shall contain at least the date of
- 28 the quotation, the name of the vendor and the vendor's
- 29 representative, the supplies which were the subject of the
- 30 quotation and the price of the supplies. Written price

- 1 quotations, written records of telephonic price quotations and
- 2 memoranda shall be retained for a period of three years.
- 3 (b) The board of school directors shall accept the bid of
- 4 the lowest responsible bidder, kind, quality, and material being
- 5 equal, but shall have the right to reject any and all bids, or
- 6 select a single item from any bid. The board of school directors
- 7 in any district may authorize or appoint the secretary of the
- 8 board or other executive as purchasing agent for the district,
- 9 with authority to purchase supplies costing less than [ten
- 10 thousand dollars (\$10,000)] twenty-five thousand dollars
- 11 (\$25,000), subject to annual adjustment under section 116.
- 12 (c) The following shall be exempt from the above provisions:
- 13 maps, music, globes, charts, educational films, filmstrips,
- 14 prepared transparencies and slides, pre-recorded magnetic tapes
- 15 and disc recordings, textbooks, games, toys, prepared kits,
- 16 flannel board materials, flash cards, models, projectuals and
- 17 teacher demonstration devices necessary for school use.
- 18 (d) No board of school directors shall evade the provisions
- 19 of this section as to advertising for bids or purchasing
- 20 materials piecemeal for the purpose of obtaining prices under
- 21 [ten thousand dollars (\$10,000)] twenty-five thousand dollars
- 22 (\$25,000), subject to annual adjustment under section 116, upon
- 23 transactions which should, in the exercise of reasonable
- 24 discretion and prudence, be conducted as one transaction
- 25 amounting to more than [ten thousand dollars (\$10,000)] twenty-
- 26 <u>five thousand dollars (\$25,000), subject to annual adjustment</u>
- 27 under section 116. This provision is intended to make unlawful
- 28 the practice of evading advertising requirements by making a
- 29 series of purchases or contracts each for less than the
- 30 advertising requirement price, or by making several simultaneous

- 1 purchases or contracts each below said price, when in either
- 2 case the transaction involved should have been made as one
- 3 transaction for one price.
- 4 Section 4. Section 1913-B.1(c) of the act, added December 9,
- 5 2002 (P.L.1472, No.187), is amended to read:
- 6 Section 1913-B.1. Contracts for Construction, Repair,
- 7 Renovation or Maintenance.--* * *
- 8 (c) All contracts, other than contracts for the retention of
- 9 architects and engineers, authorized by this section which
- 10 exceed [ten thousand dollars (\$10,000) or any larger amount as
- 11 otherwise provided for in 62 Pa.C.S. (relating to procurement)]
- 12 <u>twenty-five thousand dollars (\$25,000)</u>, <u>subject to annual</u>
- 13 <u>adjustment under section 116</u>, shall be advertised in the manner
- 14 provided by law and competitively bid and awarded to the lowest
- 15 responsible bidder. In case of emergencies and notwithstanding
- 16 any other provision of this section to the contrary, the board
- 17 of trustees may make or authorize others to make an emergency
- 18 procurement whenever a threat exists to public health, welfare
- 19 or safety or circumstances outside the control of the college
- 20 and creates an urgency of need which does not permit the delay
- 21 involved in using more formal competitive methods. Whenever
- 22 practical, in the case of a procurement of a supply, at least
- 23 two (2) bids shall be solicited. A written determination of the
- 24 basis for the emergency and for the selection of the particular
- 25 contractor shall be included in the contract file.
- 26 * * *
- 27 Section 5. Section 2003-A.1(c) of the act, amended July 11,
- 28 1990 (P.L.424, No.103), is amended to read:
- 29 Section 2003-A.1. Project Contracts.--* * *
- 30 (c) All contracts, other than contracts for the retention of

- 1 architects and engineers, authorized by this section which
- 2 exceed [ten thousand dollars (\$10,000)] twenty-five thousand
- 3 dollars (\$25,000), subject to annual adjustment under section
- 4 <u>116</u>, shall be advertised in the manner provided by law and
- 5 competitively bid and awarded to the lowest responsible bidder.
- 6 In case of emergencies and notwithstanding any other provision
- 7 of this section to the contrary, the chancellor may make or
- 8 authorize others to make an emergency procurement whenever a
- 9 threat exists to public health, welfare or safety or
- 10 circumstances outside the control of the State system and
- 11 creates an urgency of need which does not permit the delay
- 12 involved in using more formal competitive methods. Whenever
- 13 practical, in the case of a procurement of a supply, at least
- 14 two (2) bids shall be solicited. A written determination of the
- 15 basis for the emergency and for the selection of the particular
- 16 contractor shall be included in the contract file.
- 17 * * *
- 18 Section 6. Section 2010-A(10) of the act, amended April 27,
- 19 1998 (P.L.270, No.46), is amended to read:
- 20 Section 2010-A. Power and Duties of Institution
- 21 Presidents. -- The president of each institution shall be
- 22 appointed by the board. The president shall be the chief
- 23 executive officer of that institution. He shall have the right
- 24 to attend all meetings of the council of that institution and
- 25 shall have the right to speak on all matters before the council
- 26 but not to vote. Subject to the stated authority of the board
- 27 and the council, each president shall have the following powers
- 28 and duties:
- 29 * * *
- 30 (10) Within the limitations of the operating budget and

- 1 other available funds in accordance with the procedures
- 2 established by the board and with the approval of the local
- 3 council, to negotiate and award all contracts for equipment,
- 4 services and supplies in excess of a cost of [ten thousand
- 5 dollars (\$10,000)] twenty-five thousand dollars (\$25,000),
- 6 <u>subject to annual adjustment under section 116</u>, on a competitive
- 7 bid basis and to purchase instructional, educational,
- 8 extracurricular, technical, administrative, custodial and
- 9 maintenance equipment and supplies not in excess of a cost of
- 10 [ten thousand dollars (\$10,000)] twenty-five thousand dollars
- 11 (\$25,000), subject to annual adjustment under section 116,
- 12 without competitive bidding, except that such items shall not be
- 13 bought in series to avoid the dollar ceiling.

- 15 Section 7. This act shall apply to contracts and purchases
- 16 advertised on or after January 1 of the year following the
- 17 effective date of this section.
- 18 Section 8. This act shall take effect in 60 days.
