AN ACT

- Amending the act of September 27, 1961 (P.L.1700, No.699), entitled "An act relating to the regulation of the practice of pharmacy, including the sales, use and distribution of 4 drugs and devices at retail; and amending, revising, consolidating and repealing certain laws relating thereto," further providing for licensure; and imposing functions on 6 the Commissioner of Professional and Occupational Affairs and 7 8 the Legislative Reference Bureau. 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. Section 5(a) and (b) of the act of September 27, 12 1961 (P.L.1700, No.699), known as the Pharmacy Act, are amended 13 by adding clauses to read: 14 Section 5. Refusal to Grant, Revocation and Suspension .-- (a) 15 The board shall have the power to refuse, revoke or suspend the license of any pharmacist upon proof satisfactory to it that the 16 17 pharmacist: 18
- 19 (13) Set an unreasonable fee for repackaging and relabeling
- 20 pharmaceuticals in violation of a statutory provision relating

- 1 to fees for providing long-term care patients access to
- 2 pharmaceuticals.
- 3 (b) The board shall have the power to refuse, revoke or
- 4 suspend the permit of any pharmacy upon proof satisfactory to it
- 5 that:

- 7 (6) The holder of the permit set an unreasonable fee for
- 8 repackaging and relabeling pharmaceuticals in violation of a
- 9 statutory provision relating to fees for providing long-term
- 10 care patients access to pharmaceuticals.

- 12 Section 2. When the Commissioner of Professional and
- 13 Occupational Affairs determines that legislation providing for
- 14 long-term care patient access to pharmaceuticals is in effect,
- 15 the commissioner shall transmit notice of the determination to
- 16 the Legislative Reference Bureau for publication in the
- 17 Pennsylvania Bulletin.
- 18 Section 3. This act shall take effect as follows:
- 19 (1) The following provisions shall take effect
- 20 immediately:
- 21 (i) Section 2 of this act.
- 22 (ii) This section.
- 23 (2) The remainder of this act shall take effect upon
- 24 publication of the notice under section 2 of this act.
