Amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated 3 Statutes, further providing for failure to comply with 4 registration of sexual offenders requirements and for information made available on the Internet. 5 The General Assembly of the Commonwealth of Pennsylvania 6 7 hereby enacts as follows: 8 Section 1. Failure to comply with registration of sexual offenders 11 requirements. 12 [(b) Grading for offenders who must register for ten 13 14 years.--15 Except as provided in paragraph (2), an individual subject to registration under 42 Pa.C.S. § 9795.1(a) who 16 violates subsection (a)(1) or (2) commits a misdemeanor of 17

- 5 subject to registration only the following information shall
- 6 be posted on the Internet website:

- 9 (iii) the <u>street address</u>, city, county and zip code
- of all residences;
- 11 (iv) the <u>street address</u>, city, county and zip code
- of any institution or location at which the person is
- enrolled as a student;
- 14 (v) the city, county and zip code of any employment
- 15 location;
- 16 (vi) a photograph of the offender, which shall be
- 17 updated not less than annually;
- 18 (vii) a description of the offense or offenses which
- triggered the application of this subchapter; and
- 20 (viii) the date of the offense and conviction, if
- 21 available.

- 23 Section 3. This act shall take effect in 60 days.
