AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- 2 Consolidated Statutes, providing for information relating to
- 3 prospective host families.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 23 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 6344.1. Information relating to prospective host families.
- 9 (a) Investigation. -- In addition to the requirements set
- 10 forth in the United States Department of State regulations, a
- 11 sponsor shall require all members of a family hosting an
- 12 exchange visitor who are at least 18 years of age to submit to
- 13 all requirements set forth in section 6344(b) (relating to
- 14 <u>information relating to prospective child-care personnel).</u>
- 15 (b) Grounds for denial. -- A sponsor shall deny a family the
- 16 ability to host an exchange visitor if any of the criteria

- 1 listed in section 6344(c) apply to any member of the prospective
- 2 host family who is at least 18 years of age.
- 3 (c) Applicability. -- This section applies to the sponsor of a
- 4 person who applies to provide care, quidance and supervision in
- 5 the person's home to an exchange visitor.
- 6 (d) Definitions.--As used in this section, the following
- 7 words and phrases shall have the meanings given to them in this
- 8 <u>subsection:</u>
- 9 <u>"Exchange visitor." A person who is under 18 years of age,</u>
- 10 is a foreign national, has been selected by a sponsor to
- 11 participate in an exchange visitor program and seeks to enter or
- 12 <u>has entered the United States temporarily on a J-1 visa.</u>
- 13 <u>"Exchange visitor program." An international exchange</u>
- 14 program administered by the United States Department of State.
- 15 <u>"Sponsor." A legal entity designated by the Secretary of</u>
- 16 State of the United States Department of State to conduct an
- 17 exchange visitor program.
- 18 Section 2. This act shall take effect in 60 days.
