AN ACT

- 1 Amending the act of May 27, 1953 (P.L.244, No.34), entitled "An
- 2 act relating to and regulating the contracts of incorporated
- 3 towns and providing penalties," further providing for power to
- 4 convey.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 1.1 of the act of May 27, 1953 (P.L.244,
- 8 No.34), entitled "An act relating to and regulating the
- 9 contracts of incorporated towns and providing penalties, " added
- 10 October 31, 1985 (P.L.297, No.70), is amended to read:
- 11 Section 1.1. Power to Convey. -- (a) Each incorporated town
- 12 may purchase, acquire by gift or otherwise, hold, lease, let and
- 13 convey, by sale or lease, such real and personal property as
- 14 shall be deemed to be in the best interest of the town:
- 15 Provided, That no real estate owned by the town shall be sold

- 1 for a consideration in excess of fifteen hundred dollars except
- 2 to the highest bidder after due notice by advertisement for bids
- 3 in one newspaper of general circulation in the town. The
- 4 advertisement shall be published once, not less than ten days
- 5 prior to the date fixed for the opening of bids, and the date
- 6 for opening bids shall be announced in the advertisement. The
- 7 acceptance of bids shall be made only by public announcement at
- 8 a regular or special meeting of council. All bids shall be
- 9 accepted on the condition that payment of the purchase price in
- 10 full shall be made within sixty days of the acceptance of bids.
- 11 Real estate owned by a town may be sold at a consideration of
- 12 fifteen hundred dollars or less without advertisement of
- 13 competitive bidding only after council estimates the value
- 14 thereof upon receipt of an appraisal by a qualified real estate
- 15 appraiser.
- 16 (b) Except as otherwise hereinafter provided in the case of
- 17 personal property of an estimated sale value of less than [two
- 18 hundred] one thousand dollars, no town personal property shall
- 19 be disposed of, by sale or otherwise, except upon approval of
- 20 council, by ordinance or resolution. In cases where council
- 21 shall approve a sale of such property, it shall estimate the
- 22 sale value of the entire lot to be disposed of. If council shall
- 23 estimate the sale value to be [two hundred] one thousand dollars
- 24 or more, the entire lot shall be advertised for sale once, in at
- 25 least one newspaper of general circulation in the town, not less
- 26 than ten days prior to the date fixed for the opening of bids or
- 27 public auction, and such date of opening of bids or public
- 28 auction shall be announced in such advertisement, and sale of
- 29 the property so advertised shall be made to the best responsible
- 30 bidder. The advertisement for electronic auction sales

- 1 authorized in subsection (c.1) shall include the Internet
- 2 <u>address or means of accessing the electronic auction and the</u>
- 3 <u>date</u>, <u>time</u> and <u>duration</u> of the electronic auction. Council shall
- 4 have authority, by resolution, to adopt a procedure for the sale
- 5 of surplus personal property of an estimated sale value of less
- 6 than [two hundred] one thousand dollars, and the approval of
- 7 council shall not be required for any individual sale that shall
- 8 be made in conformity to such procedure.
- 9 (c) The provisions of this section shall not be mandatory
- 10 where town property is to be traded in or exchanged for new town
- 11 property.
- 12 (c.1) A "public auction" of personal property shall include

- 13 <u>an online or electronic auction sale.</u> A PUBLIC AUCTION OF
- 14 PERSONAL PROPERTY MAY BE CONDUCTED BY MEANS OF AN ONLINE OR
- 15 <u>ELECTRONIC AUCTION SALE</u>. During an electronic auction sale, bids
- 16 shall be accepted electronically at the time and in the manner
- 17 <u>designated in the advertisement. During the electronic auction,</u>
- 18 each bidder shall have the capability to view the bidder's bid
- 19 rank or the high bid price. Bidders may increase their bid
- 20 prices during the electronic auction. The record of the
- 21 <u>electronic auction shall be accessible for public inspection.</u>
- 22 The purchase price shall be paid by the high bidder immediately
- 23 or at a reasonable time after the conclusion of the electronic
- 24 <u>auction as determined by council. In the event that shipping</u>
- 25 costs are incurred, they shall be paid by the high bidder.
- 26 (c.2) A town that has complied with the advertising
- 27 requirements of subsection (b) may provide additional public
- 28 notice of the sale by bids or public auction in any manner
- 29 <u>deemed appropriate by council.</u>
- 30 (d) The provisions of this section requiring advertising for

- 1 bids and sale to the highest bidder shall not apply where town
- 2 real or personal property is to be sold to a county, city,
- 3 borough, town, township, institution district, school district,
- 4 volunteer fire company, volunteer ambulance service or volunteer
- 5 rescue squad located within the town, or [municipal] an
- 6 authority [pursuant to the act of May 2, 1945 (P.L.382, No.164),
- 7 known as the "Municipality Authorities Act of 1945,"] as defined
- 8 in 53 Pa.C.S. § 5602 (relating to definitions), or is to be sold
- 9 to a non-profit corporation engaged in community industrial
- 10 development or where real property is to be sold to a person for
- 11 his exclusive use in an industrial development program, or where
- 12 real property is to be sold to a non-profit corporation
- 13 organized as a public library for its exclusive use as a
- 14 library, or where real property is to be sold to a non-profit
- 15 medical service corporation or to a non-profit housing
- 16 corporation. When real property is to be sold to a non-profit
- 17 corporation organized as a public library for its exclusive use
- 18 as a library or to a non-profit medical service corporation or
- 19 to a non-profit housing corporation, council may elect to accept
- 20 such nominal consideration for such sale as it shall deem
- 21 appropriate. Real property sold pursuant to this section to a
- 22 volunteer fire company, volunteer ambulance service or volunteer
- 23 rescue squad, non-profit medical service corporation or to a
- 24 non-profit housing corporation shall be subject to the condition
- 25 that, when the property is not used for the purposes of the
- 26 company, service, squad or the corporation, the property shall
- 27 revert to the town.
- 28 Section 2. This act shall take effect immediately.
