## AN ACT

- 1 Providing for a memorandum of understanding between the
- 2 Commonwealth and the United States Department of Justice or
- 3 Department of Homeland Security.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Security and
- 8 Immigration Compliance Act.
- 9 Section 2. Law enforcement.
- 10 (a) Memorandum of understanding. -- The Pennsylvania State
- 11 Police is authorized and directed to negotiate the terms of a
- 12 memorandum of understanding between the Commonwealth and the
- 13 United States Department of Justice or Department of Homeland
- 14 Security concerning the enforcement of Federal immigration and
- 15 customs laws, detention and removals and investigations in this
- 16 Commonwealth.

- 1 (b) Signatures.--The memorandum of understanding shall be
- 2 signed on behalf of the Commonwealth by the Commissioner of
- 3 Pennsylvania State Police and the Governor or as otherwise
- 4 required by the appropriate Federal agency.
- 5 (c) Training. -- The Pennsylvania State Police shall designate
- 6 appropriate law enforcement officers to be trained pursuant to
- 7 the memorandum of understanding. The training shall be funded
- 8 pursuant to the Department of Homeland Security Appropriations
- 9 Act, 2006 (Public Law 1009-90, 119 Stat. 2064) or any subsequent
- 10 source of Federal funding. The provisions of this subsection
- 11 shall take effect upon the provision of the funding.
- 12 (d) Enforcement.--A law enforcement officer certified as
- 13 trained in accordance with the memorandum of understanding shall
- 14 be authorized to enforce Federal immigration and customs laws
- 15 while performing within the scope of the officer's authorized
- 16 duties.
- 17 Section 20. Effective date.
- 18 This act shall take effect in 60 days.
