## AN ACT

- 1 Amending the act of July 25, 1961 (P.L.849, No.367), entitled 2 "An act authorizing facsimile signatures and seals of certain 3 public officials; imposing duties upon the Secretary of the
- 4 Commonwealth; and providing penalties, "further providing for
- 5 definitions.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 1 of the act of July 25, 1961 (P.L.849,
- 9 No.367), known as the Uniform Facsimile Signature of Public
- 10 Officials Act, amended December 10, 1974 (P.L.828, No.276), is
- 11 amended to read:
- 12 Section 1. Definitions.--As used in this act--
- 13 (a) "Public Security" means a bond, note, certificate of
- 14 indebtedness, or other obligation for the payment of money,
- 15 issued by this Commonwealth or by any of its departments,
- 16 agencies, authorities, other instrumentalities, any school
- 17 district, any county of the second class or any authority
- 18 created by school districts of the Commonwealth.

- 1 (b) "Instrument of Payment" means a check, draft, warrant,
- 2 or order for the payment, delivery, or transfer of funds.
- 3 (c) "Authorized Officer" means any official of this
- 4 Commonwealth or any of its departments, agencies, authorities,
- 5 other instrumentalities, any school district[, any county of the
- 6 second class] or any authority created by school districts of
- 7 the Commonwealth whose signature to a public security or
- 8 instrument of payment is required or permitted.
- 9 (d) "Facsimile Signature" means a reproduction by engraving,
- 10 imprinting, stamping, or other means of the manual signature of
- 11 an authorized officer.
- (e) "Other Instrumentalities" means cities of the first,
- 13 second, second A and third classes, counties of the first class,
- 14 counties of the second and second A classes, counties of the
- 15 third through eighth classes, townships of the first and second
- 16 classes, towns, boroughs and municipal authorities.
- 17 Section 2. This act shall take effect in 60 days.
