AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania 2 Consolidated Statutes, further providing for burglary AND FOR <— 3 CRIMINAL HISTORY RECORD EXPUNGEMENT.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 3502 of Title 18 of the Pennsylvania <--
- 7 Consolidated Statutes is amended to read:
- 8 SECTION 1. SECTIONS 3502 AND 9122(B) AND (B.1) OF TITLE 18 <---
- 9 OF THE PENNSYLVANIA CONSOLIDATED STATUTES ARE AMENDED TO READ:
- 10 § 3502. Burglary.
- 11 [(a) Offense defined.--A person is guilty of burglary if he
- 12 enters a building or occupied structure, or separately secured
- 13 or occupied portion thereof, with intent to commit a crime
- 14 therein, unless the premises are at the time open to the public
- 15 or the actor is licensed or privileged to enter.
- 16 (b) Defense.--It is a defense to prosecution for burglary
- 17 that the building or structure was abandoned.]

- 1 (a) Offense defined. -- A person commits the offense of
- 2 burglary if, with the intent to commit a crime therein, the
- 3 person:
- 4 (1) enters a building or occupied structure, or
- 5 <u>separately secured or occupied portion thereof that is</u>
- 6 <u>adapted for overnight accommodations in which at the time of</u>
- 7 <u>the offense any person is present;</u>
- 8 (2) enters a building or occupied structure, or
- 9 <u>separately secured or occupied portion thereof that is</u>
- 10 <u>adapted for overnight accommodations in which at the time of</u>
- the offense no person is present;
- 12 (3) enters a building or occupied structure, or
- 13 <u>separately secured or occupied portion thereof that is not</u>
- 14 adapted for overnight accommodations in which at the time of
- the offense any person is present; or
- 16 (4) enters a building or occupied structure, or
- 17 <u>separately secured or occupied portion thereof that is not</u>
- 18 adapted for overnight accommodations in which at the time of
- 19 the offense no person is present.
- 20 (b) Defense. -- It is a defense to prosecution for burglary if
- 21 any of the following exist at the time of the commission of the
- 22 offense:
- 23 (1) The building or structure was abandoned.
- 24 (2) The premises are open to the public.
- 25 (3) The actor is licensed or privileged to enter.
- 26 (c) Grading.--
- 27 (1) Except as provided in paragraph (2), burglary is a
- 28 felony of the first degree.
- 29 (2) [If the building, structure or portion entered is
- 30 not adapted for overnight accommodation and if no individual

1 is present at the time of entry, burglary is a felony of the 2 second degree.] An offense under subsection (a)(4) is a 3 felony of the second degree. 4 (d) Multiple convictions. -- A person may not be [convicted] <----5 SENTENCED both for burglary and for the offense which it was his <--intent to commit after the burglarious entry or for an attempt 6 to commit that offense, unless the additional offense 7 8 constitutes a felony of the first or second degree. 9 § 9122. EXPUNGEMENT. <----* * * 10 11 (B) GENERALLY.--CRIMINAL HISTORY RECORD INFORMATION MAY BE 12 EXPUNGED WHEN: 13 [AN] AN INDIVIDUAL WHO IS THE SUBJECT OF THE INFORMATION REACHES 70 YEARS OF AGE AND HAS BEEN FREE OF 14 ARREST OR PROSECUTION FOR TEN YEARS FOLLOWING FINAL RELEASE 15 FROM CONFINEMENT OR SUPERVISION[; OR]. 16 17 [AN] AN INDIVIDUAL WHO IS THE SUBJECT OF THE 18 INFORMATION HAS BEEN DEAD FOR THREE YEARS. 19 (3) (I) AN INDIVIDUAL WHO IS THE SUBJECT OF THE 20 INFORMATION PETITIONS FOR EXPUNGEMENT OF THE INFORMATION 21 AND THE INDIVIDUAL HAS BEEN FREE OF ARREST OR PROSECUTION 22 FOLLOWING FINAL RELEASE FROM CONFINEMENT OR SUPERVISION FOR THE GREATER OF THE FOLLOWING TIME PERIODS: 23 24 (A) IN THE CASE OF A SUMMARY OFFENSE, FIVE 25 YEARS. 26 (B) IN THE CASE OF A MISDEMEANOR OF THE THIRD 27 DEGREE, SEVEN YEARS. 28 (C) IN THE CASE OF A MISDEMEANOR OF THE SECOND DEGREE, TEN YEARS. 29 30 (II) THIS PARAGRAPH SHALL NOT APPLY TO ANY

1 INDIVIDUAL WHO HAS BEEN CONVICTED OF: 2 (A) AN OFFENSE PUNISHABLE BY IMPRISONMENT OF 3 MORE THAN TWO YEARS. 4 (B) FOUR OR MORE OFFENSES PUNISHABLE BY 5 IMPRISONMENT OF ONE OR MORE YEARS. (C) A VIOLATION OF SECTION 3126 (RELATING TO 6 7 INDECENT ASSAULT). (D) A VIOLATION OF SECTION 3129 (RELATING TO 8 9 SEXUAL INTERCOURSE WITH ANIMAL). 10 (E) A VIOLATION OF SECTION 5511 (RELATING TO 11 CRUELTY TO ANIMALS). 12 (B.1) PROHIBITION. -- A COURT SHALL NOT HAVE THE AUTHORITY TO 13 ORDER EXPUNGEMENT OF THE DEFENDANT'S ARREST RECORD WHERE THE 14 DEFENDANT WAS PLACED ON ACCELERATED REHABILITATIVE DISPOSITION FOR A VIOLATION OF ANY OFFENSE SET FORTH IN ANY OF THE FOLLOWING 15 16 WHERE THE VICTIM IS UNDER 18 YEARS OF AGE: 17 SECTION 3121 (RELATING TO RAPE). 18 SECTION 3122.1 (RELATING TO STATUTORY SEXUAL ASSAULT). 19 SECTION 3123 (RELATING TO INVOLUNTARY DEVIATE SEXUAL 20 INTERCOURSE). SECTION 3124.1 (RELATING TO SEXUAL ASSAULT). 21 22 SECTION 3125 (RELATING TO AGGRAVATED INDECENT ASSAULT). 23 SECTION 3126 (RELATING TO INDECENT ASSAULT). 24 SECTION 3127 (RELATING TO INDECENT EXPOSURE). 25 SECTION 5902(B) (RELATING TO PROSTITUTION AND RELATED 26 OFFENSES). 27 SECTION 5903 (RELATING TO OBSCENE AND OTHER SEXUAL 28 MATERIALS AND PERFORMANCES). 29 * * * 30 Section 2.
