AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 3 provisions applicable as well to private and parochial 4 schools; amending, revising, consolidating and changing the 5 laws relating thereto, " establishing the Science Technology 6 Partnership Program; and providing for State grants. 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known 10 as the Public School Code of 1949, is amended by adding an 11 article to read: 12 ARTICLE XV-F 13 SCIENCE TECHNOLOGY PARTNERSHIPS 14 Section 1501-F. Scope. 15 This article relates to science technology partnerships. Section 1502-F. Definitions. 16

The following words and phrases when used in this article

shall have the meanings given to them in this section unless the

- 1 context clearly indicates otherwise:
- 2 <u>"Department." The Department of Education of the</u>
- 3 <u>Commonwealth</u>.
- 4 "Higher education institution." Any public or private two-
- 5 year or four-year or higher postsecondary institution in this
- 6 Commonwealth that has been accredited at the college level by an
- 7 <u>accrediting agency recognized by the Federal Secretary of</u>
- 8 Education.
- 9 <u>"Nonpublic school." A nonprofit school, other than a public</u>
- 10 school within this Commonwealth, wherein a resident of this
- 11 Commonwealth may legally fulfill the compulsory school
- 12 attendance requirements of this act and which meets the
- 13 requirements of Title VI of the Civil Rights Act of 1964 (Public
- 14 Law 88-352, 78 Stat. 241).
- 15 <u>"Program." The Science Technology Partnership Program</u>
- 16 <u>established in section 1503-F (relating to Science Technology</u>
- 17 <u>Partnership Program</u>).
- 18 "Public school." Any school owned or operated by a public
- 19 school district established under this act, including any school
- 20 <u>established pursuant to Article XVII-A (relating to charter</u>
- 21 schools).
- 22 "School." A public or nonpublic school.
- 23 <u>"Science technology partnership" or "partnership." A science</u>
- 24 <u>technology partnership established under section 1504-F</u>
- 25 (relating to science technology partnerships).
- 26 "Scientific or technical equipment." Technical or electronic
- 27 equipment used in teaching science courses, including laboratory
- 28 equipment. The equipment may include equipment that is not
- 29 routinely used in the teaching of science but that is commonly
- 30 used in the workplace and the fields of health, environment,

- 1 <u>scientific research</u>, <u>biology</u>, <u>chemistry</u>, <u>geology or other earth</u>
- 2 sciences, physics or any other scientific field.
- 3 <u>"Secretary." The Secretary of Education of the Commonwealth.</u>
- 4 <u>Section 1503-F. Science Technology Partnership Program.</u>
- 5 (a) Establishment. -- The Science Technology Partnership
- 6 Program is hereby established. The purpose of the program shall
- 7 be to improve science education in schools and school districts
- 8 that are members of science technology partnerships by:
- 9 <u>(1) Making scientific or technical equipment available</u>
- 10 to students.
- 11 (2) Augmenting the science curriculum.
- 12 (3) Providing additional professional development
- opportunities to educators in the sciences.
- 14 (b) Administration. -- The department shall administer a grant
- 15 program that awards grants to qualified higher education
- 16 <u>institutions that are members of the science technology</u>
- 17 partnerships.
- 18 (c) Criteria for funding.--To implement the program, the
- 19 department shall request proposals from higher education
- 20 <u>institutions that are members of science technology partnerships</u>
- 21 and may award grants to such institutions that meet all of the
- 22 following criteria:
- 23 (1) Have established a partnership consistent with the
- 24 <u>requirements of section 1504-F (relating to science</u>
- 25 <u>technology partnerships</u>) and provided a copy of the
- 26 partnership agreement to the department.
- 27 (2) Demonstrate how the partnership will make science
- 28 <u>technology equipment available to students enrolled in</u>
- 29 <u>schools that are partnership members.</u>
- 30 (3) Demonstrate how the partnership will augment the

- science curriculum of schools that are partnership members.
- 2 (4) Demonstrate how the partnership will provide
- 3 <u>additional professional development opportunities to</u>
- 4 educators employed by schools or school districts that are
- 5 <u>partnership members</u>.
- 6 (5) Have adopted a proposed budget describing the
- 7 <u>scientific and technical equipment that will be purchased or</u>
- 8 leased with grant funds.
- 9 (d) Grant awards.--The department shall award grants to
- 10 higher education institutions that are qualified applicants.
- 11 Grants shall be used for the purchase or lease of scientific or
- 12 <u>technical equipment and for the development of programs of</u>
- 13 <u>instruction for members of a partnership.</u>
- 14 <u>Section 1504-F. Science technology partnerships.</u>
- 15 (a) Establishment.--A higher education institution may form
- 16 <u>a partnership with schools or school districts</u>. A partnership
- 17 must include a minimum of three public schools or school
- 18 districts.
- 19 (b) Partnership agreement. -- The higher education institution
- 20 and the schools or school districts shall enter into a written
- 21 agreement defining the responsibilities of the partnership
- 22 members. The agreement shall include all of the following:
- 23 (1) The responsibilities of the higher education
- institution in providing services to each partnership member.
- 25 (2) The responsibilities of the schools or school
- 26 districts in coordinating with the higher education
- 27 institution.
- 28 (3) A description of the scientific or technical
- 29 <u>equipment that shall be provided to each partnership member.</u>
- 30 (4) A description of the program of instruction that

- will be provided to each partnership member by the higher
- 2 education institution.
- 3 (5) The courses of science instruction and grade levels
- 4 that will be augmented by scientific or technical equipment
- 5 <u>through the partnership and how scientific or technical</u>
- 6 equipment will be used to augment such courses of
- 7 instruction.
- 8 (6) The manner in which access to scientific or
- 9 <u>technical equipment will be provided to students and</u>
- 10 <u>teachers</u>.
- 11 (7) The professional development activities that will be
- 12 provided to science teachers employed by partnership members.
- (c) Forward to department. -- To be eligible to participate in
- 14 the program, a partnership must forward a certified copy of its
- 15 partnership agreement to the department.
- 16 <u>Section 1505-F. Powers and duties of department.</u>
- 17 The department shall promulgate rules, regulations and
- 18 procedures necessary to implement the program.
- 19 Section 1506-F. Annual report.
- The secretary shall annually submit a report on the program
- 21 to the Governor, the chairman and minority chairman of the
- 22 Education Committee of the Senate and the chairman and minority
- 23 chairman of the Education Committee of the House of
- 24 Representatives. The report shall include all of the following
- 25 <u>information:</u>
- 26 (1) A description of the types of the partnerships
- 27 <u>created</u>.
- 28 (2) The number of higher education institutions, schools
- 29 <u>and school districts participating in the program as members</u>
- of the partnerships.

- 1 (3) The number of students participating in the program.
- 2 (4) The dollar amount of grants awarded to each higher
- 3 <u>education institution and a summary of the institution's</u>
- 4 <u>expenditures on services related to the partnership.</u>
- 5 (5) An assessment of the impact of the program on the
- 6 <u>scientific knowledge of students participating in the</u>
- 7 program.
- 8 Section 2. This act shall take effect immediately.
