AN ACT

- 1 Providing for grants to the performing arts; and conferring
- 2 functions on the Department of Community and Economic
- 3 Development, the Department of Revenue and the Office of the
- 4 Budget.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Assistance
- 9 for the Performing Arts Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Department." The Department of Community and Economic
- 15 Development of the Commonwealth.
- 16 "Eligible cost." Any of the following expenses incurred by a
- 17 performing arts organization:
- 18 (1) Expenses for the acquisition, construction,
- 19 reconstruction, expansion, extension, demolition,

- 1 improvement, rehabilitation or remodeling of interests in
- land, buildings, structures, improvements or infrastructure
- 3 of the performing arts facility.
- 4 (2) Administrative and operating costs and expenses
- 5 incurred by the performing arts organization.
- 6 "Office." The Office of the Budget of the Commonwealth.
- 7 "Performing arts organization." A nonprofit organization
- 8 that:
- 9 (1) has been in existence for at least five years; and
- 10 (2) regularly produces and performs live musical,
- 11 concert, dance, ballet and legitimate full-length play
- 12 productions in a hall or theater.
- 13 Section 3. Establishment.
- 14 There is established within the department a program to be
- 15 known as the Assistance Program for the Performing Arts. The
- 16 program shall provide grants to performing arts organizations in
- 17 this Commonwealth to assist with their administrative and
- 18 operating expenses.
- 19 Section 4. Application for program grant.
- 20 A performing arts organization located in and organized under
- 21 the laws of this Commonwealth must submit a grant application to
- 22 the department. The application must be on a department-approved
- 23 form and must include:
- 24 (1) The name and address of the applicant.
- 25 (2) An accounting of all payroll taxes collected and
- 26 paid by the applicant under Article III of the act of March
- 27 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971,
- during the prior calendar year.
- 29 (3) The number of full-time employees of the performing
- 30 arts organization.

- 1 (4) Any other information required by the department.
- 2 Section 5. Review.
- 3 (a) Department review.--Upon receipt of a completed
- 4 application, the department shall review the application and
- 5 ensure that the applicant is a bona fide performing arts
- 6 organization that has met all the requirements of the
- 7 department.
- 8 (b) Financial review.--
- 9 (1) The department shall forward the application to the
- office and the Department of Revenue. The office and the
- 11 Department of Revenue shall review the application.
- 12 Notwithstanding section 353(f) of the act of March 4, 1971
- 13 (P.L.6, No.2), known as the Tax Reform Code of 1971, the
- 14 Department of Revenue may supply the department and the
- office with information concerning the total taxes owed or
- paid by an applicant or for which the applicant may otherwise
- 17 be liable.
- 18 (2) The office may accept, reject or adjust the estimate
- of the amount of tax remitted or to be remitted to the
- 20 Commonwealth by the applicant.
- 21 Section 6. Approval.
- 22 (a) Time.--Within 60 days of receipt of the information from
- 23 the Department of Revenue, the office shall determine if the
- 24 amount of tax reported by the applicant is accurate and shall
- 25 then notify the department.
- 26 (b) Grant approval.--Upon receipt of the notification under
- 27 subsection (a), the department shall approve the application and
- 28 award the applicant a grant in the amount of verified tax paid.
- 29 (c) Accountability.--At the end of each year for which a
- 30 grant is awarded, the department shall ensure that the grant was

- 1 used for the administrative and operating expenses of the
- 2 performing arts organization.
- 3 (d) Limitations.--If sufficient funds are not appropriated
- 4 to cover the anticipated cost of the grants awarded in any given
- 5 fiscal year, the department shall prorate payments to performing
- 6 arts organizations.
- 7 Section 20. Effective date.
- 8 This act shall take effect July 1, 2005.
