## AN ACT

7	hereby enacts as follows:
8	Section 1. Section 103 of the act of December 16, 1999
9	(P.L.971, No.69), known as the Electronic Transactions Act, is
10	amended by adding a definition to read:
11	Section 103. Definitions.
12	The following words and phrases when used in this act shall
13	have the meanings given to them in this section unless the
14	context clearly indicates otherwise:

16	"United States Postal Service Electronic Postmark" or "USPS
17	EPM." An electronic service provided by the United States

1	Postal Service. that provides evidentiary proof that an	<
2	<u>electronic document existed in a certain form at a certain time</u>	
3	and such electronic document was opened at a time and date	
4	documented by the United States Post Office.	
5	Section 2. The act is amended by adding a section to read:	
6	Section 504. Electronic postmark.	
7	(a) General rule. Upon agreement between an agency or	
8	entity and any other agency or entity, communication postmarked	
9	by the United States Postal Service Electronic Postmark shall	
10	have the same force of law as the United States Post Office	
11	<u>Certified Mail Return Receipt Requested. Any governmental agency</u>	
12	or entity may devise policies and procedures for the use of the	
13	USPS EPM in respect to their agency and operations.	
14	(b) Exception. This section does not authorize the use of	
15	an electronic postmark or USPS EPM for the service of original	
16	process of a summons, complaint or other papers for the purpose	
17	of obtaining jurisdiction over a defendant in a lawsuit.

22	(D) USE OF ELECTRONIC POSTMARK	
23	(1) EXCEPT FOR EXECUTIVE AGENCIES, EACH GOVERNMENTAL	
24	AGENCY IN THIS COMMONWEALTH SHALL DETERMINE THE EXTENT TO	
25	WHICH IT WILL UTILIZE THE USPS EPM OR ANY SIMILAR SERVICE TO	
26	SEND AND ACCEPT ELECTRONIC RECORDS AND ELECTRONIC SIGNATURES	
27	TO AND FROM OTHER PERSONS. EXECUTIVE AGENCIES SHALL COMPLY
