11	(b) ExemptionsThe following persons are not required to
12	obtain a commercial driver's license in order to drive the

15	(6) A driver with a Class C license operating a school
16	bus, school vehicle or other commercial vehicle at the
17	<u>direction of authorized emergency management personnel in a</u>

1 time of declared Federal, State or local emergency. A person 2 driving a school bus, school vehicle or other commercial 3 vehicle pursuant to this paragraph shall not be subject to 4 sanctions under the provisions of this chapter or section 5 3742.1 (relating to accidents involving death or personal 6 injury while not properly licensed). 7 \* \* \* 8 SECTION 3. SECTION 7725(B), (C) AND (E) OF TITLE 75 ARE 9 AMENDED AND THE SECTION IS AMENDED BY ADDING A SUBSECTION TO 10 READ: 11 § 7725. OPERATION BY PERSONS UNDER AGE SIXTEEN. 12 \* \* \* 13 (B) OPERATION OF AN ATV BY PERSONS UNDER EIGHT YEARS OF 14 AGE.--NO PERSON UNDER EIGHT YEARS OF AGE SHALL OPERATE [A 15 SNOWMOBILE OR] AN ATV UPON STATE-OWNED LAND. 16 \* \* \* 17 (B.2) OPERATION OF A SNOWMOBILE BY PERSONS UNDER TEN YEARS 18 OF AGE.--NO PERSON UNDER TEN YEARS OF AGE SHALL OPERATE A 19 SNOWMOBILE UPON STATE-OWNED LAND. 20 (C) SNOWMOBILE AND ATV SAFETY CERTIFICATION. -- NO PERSON 8 TO 21 15 YEARS OF AGE SHALL OPERATE [A SNOWMOBILE OR] AN ATV AND NO 22 PERSON BETWEEN 10 AND 15 YEARS OF AGE SHALL OPERATE A SNOWMOBILE 23 IN THIS COMMONWEALTH UNLESS THE PERSON SATISFIES ONE OF THE 24 FOLLOWING CONDITIONS: 25 (1) IS UNDER THE DIRECT SUPERVISION OF A CERTIFIED 26 SNOWMOBILE OR ATV SAFETY INSTRUCTOR DURING A SAFETY TRAINING 27 COURSE. 28 (2) IS ON LAND OWNED OR LEASED BY A PARENT OR LEGAL 29 GUARDIAN.

30 (3) HAS RECEIVED SAFETY TRAINING AS PRESCRIBED BY THE 20060S1056B1809 - 2 - 1 DEPARTMENT AND HAS RECEIVED THE APPROPRIATE SAFETY

2 CERTIFICATE ISSUED BY THE DEPARTMENT.

3 (4) HOLDS AN APPROPRIATE SAFETY CERTIFICATE ISSUED UNDER
4 THE AUTHORITY OF ANOTHER STATE OR PROVINCE OF CANADA AND
5 RECOGNIZED BY THE DEPARTMENT.

7 (E) PERMITTING UNAUTHORIZED OPERATION.--NO OWNER OF A 8 SNOWMOBILE OR AN ATV SHALL AUTHORIZE OR PERMIT THE OPERATION 9 THEREOF WITHIN THIS COMMONWEALTH BY ANY PERSON UNDER 16 YEARS OF 10 AGE UNLESS THE PERSON UNDER 16 YEARS OF AGE IS THE HOLDER OF A 11 VALID AND APPROPRIATE SAFETY CERTIFICATE, OR EXCEPT AS 12 AUTHORIZED IN SUBSECTIONS (B), (B.2) AND (C).
