AN ACT

- 1 Amending the act of June 23, 1999 (P.L.159, No.22), entitled "An
- act providing for scholarships for persons entering into the
- field of science and technology, " further providing for
- 4 grants for persons entering the field of science and
- 5 technology.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Sections 5 and 6 of the act of June 23, 1999
- 9 (P.L.159, No.22), known as the New Economy Technology
- 10 Scholarship Act, amended June 22, 2000 (P.L.383, No.51), are
- 11 amended to read:
- 12 Section 5. SciTech Scholarships.
- 13 (a) Amount of grants.--The agency shall award a SciTech
- 14 Scholarship in the amount of [\$3,000] \$4,000 per academic year
- 15 or a lesser amount following application of Federal and State
- 16 grants under section 4(d) to a student enrolled full time in an
- 17 approved educational institution pursuing a bachelor's degree
- 18 program or its equivalent in an approved course of study. The
- 19 student must take at least 12 semester hours per semester, or

- 1 its equivalent, in an approved course of study. The grant shall
- 2 be used for educational costs related to the undergraduate
- 3 program as determined by the agency.
- 4 (b) Term of grant.--A grant shall be awarded beginning no
- 5 earlier than the second academic year of enrollment in an
- 6 approved educational institution in a bachelor's degree program
- 7 or its equivalent in an approved course of study. The grant
- 8 shall be for a maximum of three academic years or for up to four
- 9 academic years if the student is enrolled in an approved course
- 10 of study that according to the agency requires five academic
- 11 years to complete. In order to qualify for renewals beyond three
- 12 years, the student must be in compliance with the requirements
- 13 of section 4(e) and the agency must determine that the student
- 14 is making satisfactory progress toward completing a degree.
- 15 (c) Internship or work experience.--A student who accepts a
- 16 grant under this section must complete a college-approved or
- 17 university-approved internship or work experience related to the
- 18 student's approved course of study with an employer located in
- 19 this Commonwealth prior to receiving a bachelor's degree. The
- 20 student must comply with any conditions placed upon the
- 21 internship by the agency or by the department in consultation
- 22 with the Pennsylvania Workforce Investment Board. Proof of
- 23 completion of the internship or work experience requirements
- 24 must be submitted to the agency prior to graduation unless
- 25 otherwise authorized by the agency.
- 26 (d) Grades.--At the time of application, an applicant for a
- 27 SciTech Scholarship must have a cumulative grade point average
- 28 of 3.0 or higher on a scale of 4.0 or its equivalent. The agency
- 29 shall annually verify a program participant's maintenance of the
- 30 required grade point average.

- 1 Section 6. Technology Scholarship.
- 2 (a) Amounts of grants.--
- 3 (1) The agency shall award a Technology Scholarship in
- 4 the amount of [\$1,000] \$2,000 per academic year or a lesser
- 5 amount following application of Federal or State grants under
- 6 section 4(d) to a student enrolled full time in an approved
- 7 educational institution pursuing an associate's degree in an
- 8 approved course of study or in a private licensed school that
- 9 has an academic program approved by the agency. The grant
- shall be used for educational costs related to the program as
- determined by the agency.
- 12 (2) A student who is enrolled part time or is an
- incumbent worker pursuing an associate's degree in an
- 14 approved educational institution or other specialized program
- approved by the agency is eligible for a grant of 20% of
- 16 tuition and mandatory fees.
- 17 (b) Term of grant.--The grant awarded under subsection (a)
- 18 shall be for a maximum of two academic years or for up to three
- 19 academic years if the student is enrolled in an approved course
- 20 of study that according to the agency requires three academic
- 21 years to complete. In order to qualify for a grant three times,
- 22 the student must be in compliance with section 4(d), and the
- 23 institution must determine that the student is making
- 24 satisfactory progress toward completing an associate's degree or
- 25 the requirements of the certificate program.
- 26 (c) Exception.--The agency may waive the one-year employment
- 27 requirement for an incumbent worker for extenuating
- 28 circumstances related to the student's employment within the
- 29 last year.
- 30 (d) Grades.--The agency shall annually verify a program

- 1 participant's maintenance of the required grade point average.
- 2 Section 2. This act shall take effect immediately.
