## AN ACT

Amending Titles 18 (Crimes and Offenses) and 53 (Municipalities 2 Generally) of the Pennsylvania Consolidated Statutes, further providing for limitation on the regulation of firearms and 4 ammunition and for limitation on municipal powers. 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: Section 1. Section 6120(a) of Title 18 of the Pennsylvania 7 Consolidated Statutes is amended to read: § 6120. Limitation on the regulation of firearms and 9 10 ammunition. 11 (a) General rule.--[No] (1) Except as provided in paragraph (2), no county, 12 13 municipality or township may in any manner regulate the 14 lawful ownership, possession, transfer or transportation of 15 firearms, ammunition or ammunition components when carried or 16 transported for purposes not prohibited by the laws of this 17 Commonwealth.

(2) A city of the first class may adopt ordinances
