## AN ACT

Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying 3 and enumerating certain subjects of taxation and imposing taxes thereon; providing procedures for the payment, collection, administration and enforcement thereof; providing for tax credits in certain cases; conferring powers and 7 imposing duties upon the Department of Revenue, certain employers, fiduciaries, individuals, persons, corporations 9 and other entities; prescribing crimes, offenses and penalties, providing for contributions to lupus foundations. 10 11 The General Assembly of the Commonwealth of Pennsylvania 12 hereby enacts as follows: 13 Section 1. The act of March 4, 1971 (P.L.6, No.2), known as 14 the Tax Reform Code of 1971, is amended by adding a section to 15 read: Section 315.10. Contributions for Lupus Foundations. -- (a) 16 The department shall provide a space on the Pennsylvania 17 18 individual income tax return form whereby an individual may

voluntarily designate a contribution of any amount desired to

- 1 the Lupus Foundation of Pennsylvania or the Lupus Foundation of
- 2 America, Southeastern PA Chapter, Inc.
- 3 (b) The amount so designated by an individual on the income
- 4 tax return form shall be deducted from the tax refund to which
- 5 <u>such individual is entitled and shall not constitute a charge</u>
- 6 against the income tax revenues due the Commonwealth.
- 7 (c) The department shall determine annually the total amount
- 8 <u>designated pursuant to this section, less reasonable</u>
- 9 <u>administrative costs</u>, and shall report such amount to the State
- 10 Treasurer, who shall transfer such amount from the General Fund
- 11 to the Lupus Foundation of Pennsylvania or the Lupus Foundation
- 12 of America, Southeastern PA Chapter, Inc.
- 13 Section 2. The addition of section 315.10 of the act shall
- 14 apply to taxable years beginning after December 31, 2006.
- 15 Section 3. This act shall take effect in 60 days.
