AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- 2 Consolidated Statutes, further providing, in support matters,
- 3 for cooperation of government and nongovernment agencies.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 4304.1(a)(2) of Title 23 of the
- 7 Pennsylvania Consolidated Statutes is amended to read:
- 8 § 4304.1. Cooperation of government and nongovernment agencies.
- 9 (a) Cooperation of government agencies. -- Notwithstanding any
- 10 other provision of law, including the provisions of section 731
- 11 of the act of April 9, 1929 (P.L.343, No.176), known as The
- 12 Fiscal Code, all government agencies shall:
- 13 * * *
- 14 (2) Require the Social Security number of an individual

- 1 who has one on any application for a professional or
- 2 occupational license or certification; a permit; a driver's
- 3 license, including a commercial driver's license; [a
- 4 recreational license; or a marriage license. Collection of
- 5 the Social Security number shall be performed in such manner
- 6 as to protect its confidentiality. If the government agency
- 7 uses another identifying number on the face of the
- 8 application, the government agency shall advise the applicant
- 9 and shall keep the Social Security number on file at the
- 10 agency.

- 12 Section 2. This act shall take effect in 180 days.
