AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, further providing for
- 3 volunteer firefighter civil immunity; and further defining
- 4 "local agency" for purposes of matters affecting government
- 5 units.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 8332.3 of Title 42 of the Pennsylvania
- 9 Consolidated Statutes is amended to read:
- 10 § 8332.3. Volunteer firefighter civil immunity.
- 11 Volunteer firefighters shall be treated as public employees
- 12 and volunteer firefighter companies shall be treated as local
- 13 <u>agencies</u> as defined in section 8501 (relating to definitions).
- 14 This section shall not be construed to reduce or eliminate any
- 15 other immunity provided to volunteer firefighters by law.
- 16 Section 2. The definition of "local agency" in section 8501

- 1 of Title 42 is amended to read:
- 2 § 8501. Definitions.
- 3 The following words and phrases when used in this chapter
- 4 shall have, unless the context clearly indicates otherwise, the
- 5 meanings given to them in this section:
- 6 * * *
- 7 "Local agency." A government unit other than the
- 8 Commonwealth government. The term includes, but is not limited
- 9 to, an intermediate unit; [municipalities] a municipality
- 10 cooperating in the exercise or performance of governmental
- 11 functions, powers or responsibilities under 53 Pa.C.S. Ch. 23
- 12 Subch. A (relating to intergovernmental cooperation); [and
- 13 councils] <u>a council</u> of government and <u>any</u> other [entities]
- 14 entity created by two or more municipalities under 53 Pa.C.S.
- 15 Ch. 23 Subch. A[.]; and a volunteer firefighter company,
- 16 regardless of whether the company has been or is created
- 17 pursuant to relevant law or officially accorded the status of
- 18 such a company by the political subdivision which it serves.
- 19 Section 3. This act shall apply to a cause of action that
- 20 accrues on or after the effective date of this section.
- 21 Section 4. This act shall take effect in 60 days.
