## AN ACT

- 1 Establishing the Plug-in Hybrid Task Force; and providing for
- 2 its powers and duties.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Plug-in
- 7 Hybrid Task Force Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Plug-in hybrid." A vehicle which meets the applicable
- 13 Federal motor vehicle safety standards with an internal
- 14 combustion engine which also allows power to be delivered to the
- 15 drive wheels by a battery-powered electric motor. The battery
- 16 must be able to be plugged into an outlet to recharge, and the
- 17 vehicle must have the ability to travel at least five miles

- 1 powered substantially by electricity or by other forms of power
- 2 other than an internal combustion engine.
- 3 "Task force." The Plug-in Hybrid Task Force established by
- 4 this act.
- 5 Section 3. Task force.
- 6 (a) Establishment.--The Plug-in Hybrid Task Force is
- 7 established as an advisory board.
- 8 (b) Composition.--The task force shall consist of members as
- 9 follows:
- 10 (1) The Secretary of Environmental Protection or a
- 11 designee.
- 12 (2) The Secretary of General Services or a designee.
- 13 (3) The Secretary of Revenue or a designee.
- 14 (4) The Secretary of Transportation or a designee.
- 15 (5) The chairman of the Pennsylvania Public Utility
- 16 Commission or a designee.
- 17 (6) One member appointed by each of the following:
- 18 (i) The President pro tempore of the Senate.
- 19 (ii) The Minority Leader of the Senate.
- 20 (iii) The Speaker of the House of Representatives.
- 21 (iv) The Minority Leader of the House of
- 22 Representatives.
- 23 (c) Chairperson. -- The Governor shall designate one member
- 24 who shall serve as chairperson of the task force.
- 25 (d) Administration. -- The Governor shall assign a department
- 26 or departments to provide administrative support and funding for
- 27 the task force.
- 28 Section 4. Duties.
- 29 The task force shall:
- 30 (1) Review existing laws, regulations, tariffs and

- 1 policies that relate to plug-in hybrids.
- 2 (2) Meet with representatives from the automotive,
- 3 battery, utility and energy industry, transportation and
- 4 fleet car managers, environmentalists, first responders and
- 5 other relevant parties.
- 6 (3) Seek and accept public comment on its effort and
- 7 recommendations.
- 8 (4) Examine and report on the following:
- 9 (i) How the use of plug-in hybrids would impact this
- 10 Commonwealth.
- 11 (ii) The options for maximizing the use of plug-in
- 12 hybrids by State agencies for affordable transportation.
- 13 (iii) Potential cost savings for State agencies as a
- result of the use of plug-in hybrids.
- 15 (iv) Measures to undertake to accelerate the
- adoption of plug-in hybrid technology.
- 17 (5) Transmit a copy of its findings within one year
- 18 after the effective date of this act to:
- 19 (i) The Governor.
- 20 (ii) The Secretary of the Senate.
- 21 (iii) The Chief Clerk of the House of
- 22 Representatives.
- 23 (iv) The prothonotary of the Pennsylvania Public
- 24 Utility Commission.
- 25 (6) Post its findings on a publicly accessible Internet
- 26 website.
- 27 Section 5. Construction.
- 28 The findings of the task force shall not be binding on any
- 29 department or other agency of the Commonwealth, but may serve as
- 30 the basis for further action by the Commonwealth.

- 1 Section 6. Effective date.
- 2 This act shall take effect immediately.
