AN ACT

- 1 Prohibiting State depositories from making or maintaining
- financial loans or transactions with the Republic of Sudan, a
- 3 national corporation of the Republic of Sudan, or a
- 4 subsidiary or affiliate of a United States firm operating in
- 5 the Republic of Sudan.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Short title.
- 9 This act shall be known and may be cited as the Republic of
- 10 Sudan Divestment Act.
- 11 Section 2. Legislative findings.
- 12 The General Assembly finds that:
- 13 (1) The ongoing and deteriorating situation in the
- Republic of Sudan is widely recognized as the worst
- 15 humanitarian crisis in the world.
- 16 (2) Since February 2003, government-financed militias
- 17 have been systematically terrorizing residents of the Darfur

- 1 region in western Sudan by destroying villages, killing men,
- 2 raping women, starving children, confiscating food supplies
- 3 and blocking international assistance.
- 4 (3) This violence, which has been called ethnic
- 5 cleansing and genocide, has resulted in between 200,000 and
- 6 400,000 deaths and more than 2 million refugees.
- 7 Section 3. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- 11 "Financial institution." A Federal or State-chartered bank,
- 12 bank and trust company, savings bank, savings and loan
- 13 association, trust company or credit union.
- 14 "National corporation." A corporation, or a subsidiary or
- 15 affiliate of a corporation, that is more than 50% owned or
- 16 operated by the government of the Republic of Sudan.
- 17 "Subsidiary or affiliate of a United States company operating
- 18 in the Republic of Sudan." A company incorporated under the
- 19 laws of the Republic of Sudan, domiciled in the Republic of
- 20 Sudan and owned or operated by a United States company. A
- 21 subsidiary or affiliate shall not be construed to mean a
- 22 subsidiary or affiliate that is located in the United States.
- 23 Section 4. Divestiture.
- 24 A financial institution that is a depository of State funds
- 25 may not make or maintain financial loans or transactions with
- 26 the Republic of Sudan, a national corporation of the Republic of
- 27 Sudan or a subsidiary or affiliate of a United States company
- 28 operating in the Republic of Sudan.
- 29 Section 5. Affidavit of divestiture.
- 30 A financial institution that is a depository of State funds

- 1 shall file an affidavit with the State Treasurer attesting to
- 2 the fact it has no financial loans or transactions with the
- 3 Republic of Sudan, a national corporation of the Republic of
- 4 Sudan or a subsidiary or affiliate of a United States company
- 5 operating in the Republic of Sudan, according to the following
- 6 schedule:
- 7 (1) Within six months of the effective date of this act
- 8 for each financial institution that is currently a depository
- 9 of State funds.
- 10 (2) Before being approved as a depository of State funds
- 11 for each financial institution that is not currently a
- 12 depository of State funds.
- 13 Section 6. Effective date.
- 14 This act shall take effect immediately.
