AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," further providing for transfer of 6 records. - 4 ADDITIONAL DUTIES; IN FUNDING FOR PUBLIC LIBRARIES, PROVIDING
- 5 FOR STATE AID FOR FISCAL YEAR 2008-2009; IN REIMBURSEMENTS BY

- 14 The General Assembly of the Commonwealth of Pennsylvania
- 15 hereby enacts as follows:

- 23 the pupil has transferred. The school entity or nonpublic school
- 24 to which the student has transferred should request the record.
- 25 The sending school entity or nonpublic school shall have ten
- 26 (10) days from receipt of the request to supply a certified copy
- 27 of the student's disciplinary record. The requirements of this
- 28 section apply as well to transfers between schools within the
- 29 same school entity.
- 30 Section 2. Section 1729 A(j) of the act, added June 19, 1997 <

- 4 AFTER THE FIRST DAY OF EACH SCHOOL YEAR OR TEN (10) DAYS AFTER
- 5 THE FIRST DAY OF ATTENDANCE OF THE CHILDREN DURING A SCHOOL YEAR
- 6 IF THE CHILDREN ARE ENROLLED IN THE SCHOOL AFTER THE SCHOOL YEAR

- 9 LATER THAN JANUARY 1, 2009, EACH SCHOOL ENTITY SHALL ADOPT A
- 10 POLICY OR AMEND ITS EXISTING POLICY RELATING TO BULLYING AND

- 25 NOTICES ARE USUALLY POSTED. EACH SCHOOL ENTITY SHALL ENSURE THAT
- 26 THE POLICY AND PROCEDURES FOR REPORTING BULLYING INCIDENTS ARE
- 27 REVIEWED WITH STUDENTS WITHIN NINETY (90) DAYS AFTER THEIR
